Markets are looking vibrant

Due to good monsoon and record production, there is good enthusiasm in festivals this time. Especially the markets are looking vibrant. The business community is excited that due to the economy being on track, the purchasing power of the people has increased. Increase in purchasing power means there will be flow of cash in the marwill be flow of cash in the mar-ket this time. Actually, Indian economy is on track compared to developed countries of the world. GDP figures for the fourth quarter have been bet-ter than expected. According to the National Statistical Office, GDP growth in 2022-23 is 7.2 percent. In the financial year 2023, the economy grew by 13.1 percent in the first quarter, 6.2 percent in the secquarter, 6.2 percent in the second quarter and 4.5 percent in the third quarter. Experts had predicted GDP growth to be 4.9 to 5.5 percent in the January-March 2023 quarter. But it was much better than the estimates. It was expected that the strength in the agricultural sector and increase in domestic demand could support the Indian economy. Amid fears of recession in western countries, India has emerged as a bright star in the context of the global economy. Germany, the country with the largest economy in Europe, is stuck in recession. Whereas America is facing the threat of bankruptcy for the first time. Institutions like the World Bank and the International Monetary Fund say that the chances of a recession in India are negligible. The GDP figures prove this. The data is released by the National Statistics Office. According to NSO data, the economic growth rate is expected to be 4.5 percent in the October-December quarter. The GDP growth rate was four percent in the January-March quarter of 2021-22. According to the data, the economic growth rate in the entire financial year 2022-23 The growth rate will be 7.2 percent. In the last financial year 2021-22, it was 9.1 percent. According to the provisional estimates of Gross Value Added, the growth of the con-

struction industry in the financial year 2023 was 1.3 percent.

The growth of this sector was 11.1 percent in 2022. The National Statistics Office had predicted the country's growth rate to be seven percent in the second advance estimate. Gross domestic product measures the total value of goods and services produced within the country's borders. China's economic growth rate was 4.5 percent in the first quarter of 2023. In fact, the Reserve Bank of India had estimated the GDP growth in the fourth quarter of 2022-23 to be 5.1 percent. The Reserve Bank of India had recently said that it would not be surprised if India's GDP growth rate remains more than seven percent. Will happen. GDP figures are important for any country because they reveal the health of the country's economy. These show how the economy is performing and how the economic activities are. Policies are made on the basis of these data. However, it is a matter of satisfaction that the country is moving in a positive direction on the economic front, but still the general public is not getting relief from inflation

Will governments firewall public health from Big Tobacco at the upcoming FCTC Treaty meet?

by Shobha Shukla- CNS Tobacco industry interference in its myriad sinister forms is one of the biggest obstacles to implement the legally-binding global tobacco treaty. Unless the devious designs of Big Tobacco are thwarted and the industry is held to account legally and financially for causing irreparable damage to human life and our planet, #endTobacco will continue to remain elusive. The upcoming inter-governmental meeting of the global tobacco treaty offers a historic chance to put people before profit and advance stronger measures for tobacco control.

"Together, promoting healthier lives" is the theme of the upcoming 10th session of the Conference of the Parties (COP10) to the global tobacco treaty (formally called the World Health Organization Framework Convention on Tobacco Control -WHO FCTC). This meet will be held later this month in Panama.

A media briefing recently hosted by The Network for Accountability of Tobacco Transnationals (NATT) provided a background on the pivotal role of the global tobacco treaty in saving lives, and how the tobacco industry's tactics are trying to under-mine it. Key issues and high stakes of COP10 were also in focus.

The WHO FCTC is the first international public health and corporate accountability treaty negotiated under the auspices of the WHO. It was adopted by the World Health

Assembly on 21 May 2003 and entered into force on 27 February 2005. It has since been embraced by 183 countries, covering 90% of the world's population. Its main objective is to protect present and future generations from the devastating health, social, environmental and economic consequences of tobacco consumption and

Opening the discussion, Sabina Timco Lacazzi, Legal Officer, WHO FCTC, explained that this intergovernmental meeting of the global tobacco treaty is held once every two years, to review the implementation of the treaty and take decisions to promote its effective implementation. Discussions and decisions taken at these meetings influence tobacco control policies at a national level. COP10 will be the first in-person

treaty meeting in five years- the last in- person meeting (COP8) was held in 2018 in Geneva.

She also said that implementation of Article 19 of the treaty that addresses liability can (i) recover health care and environmental costs incurred by governments for tobacco-related harms to people; (ii) create the public climate and political will to pass and enforce the lifesaving measures enshrined in the FCTC; and (iii) expose and halt misconduct, deter future misconduct, and punish wrongdoing. To date countries like Brazil, South Korea, Canada and USA have initiated liability against the tobacco industry.

Samuel Ochieng, Executive Director, Consumer Information Executive Network (Kenya), shared examples of tobacco industry interference in Africa. It is pushing 'harm reduction products' despite there being no supporting scientific evidence that these are safer, he said. It also tries to infiltrate COP by buying tickets, giving other incentives to certain delega-tions, and has its own media plat-forms to oppose discussions and policies

Labram Musah, Executive Director, Vision for Alternative Development (Ghana) referred to the African Tobacco Industry Interference Index Report 2023 that was created to address the urgent need for monitor ing and evaluation of tobacco indus try tactics, ensuring transparency in decision-making processes, and for raising awareness, empowering policymakers, and mobilising public health advocates.


Three-cornered contest

NASA's Hubble Shares Mesmerising Image Of Jupiter In Ultraviolet View

NASA often shares stunning images of our universe, leaving space lovers mesmerised. On Monday, NASA shared an image captured by its Hubble telescope, showing the giant planet Jupiter in ultraviolet view. The image was released to honour Jupiter's opposition- when the planet and the Sun are on opposite sides of the sky, offering a unique perspective of the gas giant including its most recognisable feature, the "Great Red Spot", NASA said in its news



NASA said that the storm to the naked eye appears deeper in the UV image as high-altitude haze particles absorb light at these wavelengths.

NĂSA shared the image on Instagram and wrote, "All eyes are on Jupiter after reaching opposition, which occurs when the planet and the Sun are on opposite sides of the sky. Captured here in ultraviolet wavelengths, @NASAHubble views the gas giant in hues of blue, pink, and purple, invisible to the human eye. Scientists use ultraviolet wavelengths to further study Jupiter's storm systems, mapping deep water clouds that define Jupiter's atmosphere.^{*}

"Clouds on stormy Jupiter are far taller than scientists predicted, with some dipping 60 miles (100 km) below the cloud tops – the iconic Great Red Spot (here in ultraviolet blue) extends over 200 miles (350 km) below its highest peaks," it further said.


