Santosh Koli, close to Digvijaya, joins BJP

The round of resignations is still going on in Madhya Pradesh Congress. The process of changing sides of Congress leaders in the state is not showing any signs of stopping. In this sequence, BJP candidate from Guna Lok Sabha Jyotiraditya Scindia has made a big dent in former CM Raja Saheb Digvijay Singh. Many councilors, including Chandri Municipality President Dashrath Santosh Koli, who is closest to Digvijay Singh, have joined BJP in front of Maharaja Scindia.

This is being considered a big blow to Congress before the voting of Lok Sabha elections, because Chandri was the only assembly in Ashoknagar district where the municipality was in the

control of Congress, but now BJP has given a blow and snatched it from Congress. Now Chandri Municipality President has also joined the BJP camp. Municipality President Dashrath has taken membership of BJP in the presence of Jyotiraditya Scindia. According to the information, Jyoti-

raditya Scindia is busy in election campaign these days. In this context, he had visited Chandri on Sunday. During this late night, many councilors including Chandri Municipality President Dashrath alias Santosh Koli joined BJP. Maharaj Scindia included everyone in BJP.

Tikamgarh: Congress's Pankaj trying to compete with Dr. Virendra Kumar

Tikamgarh parliamentary constituency of Bundelkhand region, reserved for Scheduled Castes, has now gradually transformed into a stronghold of BJP.

In the last three parliamentary elections, BJP reposed its trust in Dr. Virendra Kumar, he never let that trust be broken and each time, he won with a bigger margin than before. Now again, for the fourth time, BJP has won from the same parliamentary constituency. The public has expressed confidence in him only. Here, Congress has changed its face this time. This time Pankaj Ahirwar has been fielded from here. In the last election, Congress had bet on Mrs. Kiran Ahirwar, but the way the election results came in the year 2019, now Congress has considered it more appropriate to trust Pankaj. Although a total of 8 candidates are in the fray in Tikamgarh parliamentary constituency, the main contest seems likely to be limited between BJP and Congress. Although BSP has also fielded Dalluram Ahirwar from here, but at the moment it does not appear that he will pose any challenge to both the parties in the election contest. After delimitation in the year 2008, Tikamgarh has become the new Scheduled Caste seat. Voting will be held here in the second phase on April 26. If we look at the last three Lok Sabha elections, Dr. Virendra Kumar's influence remains intact.



Attempt to capitalize on migration issue

Tikamgarh parliamentary constituency mainly includes Tikamgarh and Chhatarpur districts; the backwardness of the area is not hidden from anyone. In such a situation, people migrate in search of employment. According to local experts, every year about 5 lakh people migrate out of the district in search of work. In such a situation, the displeasure of the people is clearly visible at the local level with the Union Minister for not allowing industries to flourish here. In such a situation, Congress is trying its best to capitalize on this issue.

Along with this, Baraiya has accepted that BJP candidate Sandhya Rai, being a female candidate, could not mingle among the people of Bhind, due to which the people of Bhind district are not completely satisfied with her behavior but are dissatisfied, due to this, he will definitely benefit from it. Although he denied that he will suffer any loss due to this, the special thing is that if a BJP candidate will benefit then it will be a direct loss to Congress only.

Phool Singh Baraiya said that the people of the upper caste community have played a big role in getting his ticket. Even before his ticket was finalized, people from the upper caste community

had met him and talked about contesting the elections. Baraiya said that even though people know me as a Dalit leader, actually people from the upper caste community also like me a lot and they have played an important role in getting me the ticket. Therefore, the leaders of the political identity as per the times, want Phool Singh Baraiya to win with maximum votes.

Baraiya says that he is currently the MLA from Bhandar Assembly, hence some BJP leaders are trying to win the Lok Sabha elections, so that the Bhandar Assembly seat becomes vacant and a BJP leader can become an MLA by winning the elections. Baraiya says that he has received reports that only upper caste leaders and voters are trying for his victory.

Baraiya said that he has made preparations to oust BJP which has been in power for 9 times in Bhind, he is getting full support from his supporters and Congress party workers. Baraiya also said that his words are still not fully trusted in the Congress party. If the senior leadership of the party had believed his words from the beginning, the situation of

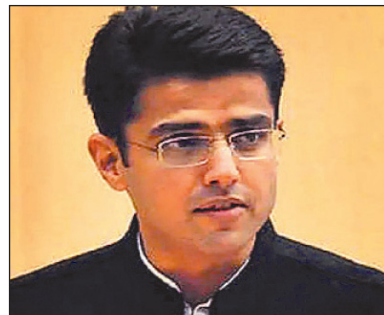
Phoolsingh Baraiya is considered the founder of BSP in Madhya Pradesh. After the rift with Mayawati, he contested the elections under the banner of his party Bahujan Sangharsh Dal. He also stayed in BJP for a short time but while being in BJP, he never climbed the stairs of BJP office in Gwalior. He was also the national vice president of Ram Vilas Paswan's Lok Janshakti Party. Then he joined Congress. Congress has made him contest the Rajya Sabha elections. Last time he was elected MLA for the second time from Bhandar seat. He obtained a BE Mechanical degree from Engineering College MITS Gwalior in 1988.

Digvijaya Singh bereaved

Bhopal: Senior Congress leader Digvijaya Singh has been bereaved. Singh's son-in-law succumbed to cancer on Sunday night. His last rites were performed on Monday in Lucknow.

Digvijaya Singh himself gave information about this on social media platform X. He wrote, "Last night my elder son-in-law Raja Ratnakar Singh Ramnagar passed away tragically. Ratnakar, 61, was suffering from cancer for almost a year. I am in Lucknow for his last rites. In this hour of grief, I am suspending the election campaign and am with my daughter Mrinalini and my family."

Meanwhile, all the programs of ex-CM scheduled for today have been cancelled. Singh is the party candidate from Rajgarh parliamentary constituency. Voting is to be held in Rajgarh on May 7.

Application for UG First ends today

BU extends date of form submission, forms will be submitted with late fees till 26th

Barkatullah University has extended the date of submission of online form for graduation i.e. UG examination. Till now, the last date for submitting the form was 10 April, but students were facing problems due to excessive ID required to submit the examination form. Also, with a special late fee of Rs 1000, the examination is scheduled from 27th April, three days before the commencement of the examination. You can do it till two days before the commencement of the examination with a special late fee of Rs 4000.

There have been many leaders in the politics of Rewa district whom the public has generously blessed from time to time in both the Assembly and Lok Sabha elections and there have been many occasions when the public has invested their energy in defeating them in the elections. The names of Yamuna Prasad Shastri, Chandramani Tripathi, Sundarlal Tiwari and Buddhasen Patel are among those fortunate leaders of Rewa

district who got the opportunity to become MP and MLA. Yamuna Prasad Shastri was elected MLA from Sirmaur assembly constituency on the ticket of Prajatantrik Socialist Party in 1962 and 1967. Shastri had lost the previous two elections (in the years 1952 and 1957 respectively). In 1972 also he had to face defeat. In the years 1977 and 1989, the people of Rewa district elected him as MP and sent him to Delhi.

Chandramani Tripathi was

elected MLA from Gudh Assembly in the year 1977 on Janata Party ticket. The people of Rewa also elected him MP twice. Tripathi was elected MP in 1998 and 2004. Only Mr. Tripathi was elected as BJP MP from Rewa parliamentary seat. It was he who opened the account of BJP here. Congress leader Sunderlal Tiwari first became MP and then contested the assembly elections and was elected as MLA. In the midterm elections held in 1999, he was a Congress candi-

date and was elected MP. Before that, Tiwari had lost the Lok Sabha constituency several times. In the year 2013, Congress had made him its candidate from Gudh assembly seat and he was successful in winning this election. In the year 2013, Tiwari had snatched Gudh seat from BJP but in the 2018 elections, BJP again captured this seat which is still intact. At present all the above mentioned three maestros in politics have ascended to heaven.

Budhsen Patel's name is also included in this link. Budhsen Patel was elected MLA from Gurh seat in the year 1993 on BSP ticket. In the year 1996, BSP made him the Lok Sabha candidate from Rewa and he became MP after winning the election. After leaving BSP his defection continued, after leaving BSP he joined BJP. But after a few years, his attachment has dissolved and once again he has returned home and joined BSP.
