#### Three killed as SUV hits e-rickshaw in Sultanpur

Sultanpur: Three persons were killed when an SUV hit a road divider and later rammed into an posite direction, in Lambhua area of Sultanpur district in Uttar Pradesh on Friday. Police sources said that the accident took place on Lucknow-Varanasi highway. "One of the passenger Gurudeen Nishad (55) travelling in the e-rickshaw was killed on the spot," they said. The sources said that two persons, including the e-rickshaw driver were in-jured in the incident. "The two were taken to the government medical college where the driver Rajesh (40) and an unidentified 62-year-old person died during treatment," the sources added.

Ballia: A 55-year-old man was hacked to death by unidentified persons allegedly over an affair in Bhimpura area of Ballia district in Uttar Pradesh, police sources said on Friday. "The body of the deceased was recovered from the courtyard of his house this morning," they said. Super-intendent of Police (SP) Dev Ranjan Verma said that marks of attack by a sharp weapon were found on the neck of the deceased. "The wife and son of the deceased live in Mumbai. Prima facie it seems to be a case of love affair," he said. He said that on the complaint of the family members, a case of murder has been lodged against an uniden-tified person. 
### BRS urges Cong govt not to introduce adulterated liquor in Telangana State

election have criminal cases: Report Bhubaneswar (UNI)

As many as 85 candidates elected to the 147-member Odisha Legislative Assembly in the 2024 election, have declared criminal cases pending against them, as per the Odisha Election Watch report.

The report, released to the press here on Friday, stated that 58 percent of the winning candidates have criminal cases against them. In the 2019 Assembly election, out of the 146 MLAs, 67 MLAs, constituting 46 percent, had declared criminal cases against them.

Out of the 85 winning candidates in the 2024 election who have criminal cases, 67 MLAs (46 percent) have declared serious criminal cases

pending against them, the report

An analysis of the MLAs having criminal cases in the last four elections revealed that the number has gone up from 33 percent in 2009 to 35 percent in 2014, further increasing to 46 percent in the 2019 Assembly election and 58 percent in the 2024 Assembly election.

Similarly, the MLAs having serious criminal cases have also gone up from 21 percent in 2009 to 28 percent in 2014, which further went up to 34 percent in 2019 and 47 percent in the 024 election.

The report said, on a party-wise basis, out of 78 MLAs elected from the BJP in the 2024 elections, 46 (59

ing against them. While from the 51 BJD MLAs elected in the 2024 election, 15 MLAs (29 percent) have criminal cases pending against them, eleven of the 14 elected Congress MLAs have criminal cases.

The lone CPI(M) candidate and three independents who won the 2024 election have declared criminal cases pending against them.

As far as serious criminal cases are concerned, the BJP accounted for 46 MLAs (59 percent) from the elected 78 MLAs, while 12 elected MLAs from BJD and five of the 14 elected MLAs from Congress have declared serious criminal cases

### **ECI** announces conclusion of model code of conduct

Shimla: The Election Commission of India (ECI) has officially announced the cessation of the Model Code of Conduct (MCC) following the completion of the 2024 General Elections.

The notification, signed by Senior Principal Secretary Narendra N. Butolia, marks the end of the election-relat ed restrictions that have been in place since March 16, 2024. This announce ment allows both central and state governments, as well as union territories to resume their developmental proiects and initiatives without any embargo. The 2024 General Elections, which spanned over three months, involved polling for the House of the Peo-Arunachal Pradesh, Odisha, and Sikkim, along with some by-elections.

### K'taka HC grants interim bail to Bhavani Revanna

The Karnataka High Court Friday granted interim anticipatory bail to Bhavani Revanna, the mother of suspended Janata Dal (Secular) leader Prajwal Revanna, in a case related to allegations of kidnapping linked to sexual abuse accusations against her son.
The High Court's decision

comes in response to an arrest warrant issued against Bhavani by an Additional Chief Metropolitan Magistrate (ACMM). The court has directed the police to refrain from arresting or detaining her, providing interim relief.

However, Justice Krishna S Dixit cautioned against celebrating the bail, imposing conditions to ensure cooperation with the ongoing investigation.

Under the conditions set forth by the court, Bhavani must cooperate fully with the investigation and appear before the investigat-



ing officer at 1 pm Friday. Additionally, she has been instructed not to enter specific areas where

the alleged kidnapping occurred. The allegations against Bhavani stem from accusations of involvement in the kidnapping of a woman who was reportedly sexually assaulted by her son, Prajwal. He himself is currently under arrest in connection with allegations of sexual assault on multiple women and the recording of such

The case gained widespread attention last month when over 2,900 videos depicting the assaults surfaced on pen drives left in public places across Karnataka. Amid the ensuing political turmoil, Pra-jwal left for Germany but was arrested upon his return to India on May 31. The SIT custody of Prajwal has been extended until June

Notably, both of Prajwal's parents are facing allegations related to the kidnapping of the woman assaulted by their son.

The Special Public Prosecutor representing the SIT has asserted nat Bhavani was the mastermind behind the kidnapping plot, a claim the court has taken into consideration in granting antici-
