Health insurance

Development Authority has taken an important decision in the matter of health insurance. This decision has caused a stir in insurance companies. Insurance Regulatory and Development Authority has issued a master circular on health insurance products and cancelled 55 circulars issued earlier. This is likely to curb the arrogance of the insurance companies. Till now, even after having health insurance, a person who fell ill during the insured period had to make rounds of the offices of the insurance companies for payment of the insurance amount. Even if the consumer fell ill during the insured period and informed the insurance company in time, the insurance companies used to make various excuses to avoid paying the insurance claim. Along with the demand for various treatment forms, the claim was rejected on the basis that the insured was already ill and he had taken the insurance by hiding his illness. While taking health insurance, it is the responsibility of the insurance companies to get the health of the person they are insuring checked by their authorized doctor and insure only after complete satis-

Insurance Regulatory and Development Authority has issued a master circular on health insurance and has provided that the insurance company will have to take a decision on allowing cashless treatment within one hour of the request of the policyholder and make the final settlement of the claim amount within three hours after treatment in the hospital. The authority has repealed 55 circulars issued earlier under the master circular on health insurance products. In the new insurance circular, the eligibility in the health insurance policy available to the policyholders has been brought at one place for their easy reference and at the same time emphasis has been laid on measures to ensure improved service standards of insurance claims in a seamless manner to

insurance. Now the insurance companies will have to take a decision within one hour of the insurance claim and make the final settlement of the claim amount within three hours after treatment in the hospital. Till now, consumers had to face a lot of difficulties for cashless payment of their health insurance. This new circular issued by

Insurance Regulatory Authority states that in any case, the health insurance company will have to make cashless payment of the claim made by the policyholder within three hours of receiving the discharge request from the hospital. If there is a delay of more than three hours in claim payment, then in such a situation any additional charge taken by the hospital will be borne by the insurance company. Under the new guidelines, if a health insurance holder dies during treatment in the hospital, then in this situation the insurance company will have to immediately start the process of payment of the claim. Also, the body of the deceased will also have to be removed from the hospital quickly. Also, the insurance company will have to take an immediate decision on cashless payment within one hour of receiving the insurance claim request. The authority has directed the insurance companies to complete this work by July 31, 2024. Policy holders who have more than one health insurance policy will get an opportunity to choose any one of them, under which they can get the approved claim amount. Insurers will also have to provide a customer information letter with each policy document. In case of death of the policy holder during treatment, the insurance company will act immediately on the request for claim approval process. It will also help in getting the dead body of the deceased out of the hospital immediately. Now the policy holder will not need to submit any document for claim settlement. Rather the insurer and the authority will have to obtain the documents from the hospitals themselves.

Six Key Factors Behind BJP's Defeat in Ayodhya

Particularly striking was the party's loss in Ayodhya, the site where a monumental Ram temple had been erected after years of fervent dedication. Initially confounding, the reasons behind this setback are gradually emerging, shedding light on the complex dynamics at play.

Notably, the district administration orchestrated a commendable campaign to galvanize voter participation, setting noteworthy precedents under the leadership of the District Magistrate, whom I felicitated with a record certificate.

During my visit, interactions with the local populace unveiled a palpa-ble discontent towards the BJP, simmering beneath the surface for quite some time. The electorate, harboring pent-up frustrations, awaited the opportune moment to voice their

grievances, culminating in a resounding verdict that left observers astounded.

Six primary factors have emerged as crucial in understanding the BJP's defeat in Ayodhya. Foremost among them is the deep-seated resentment among those whose homes were demolished to make way for the wide, picturesque roads that now charm tourists. Despite compensation or alternative housing arrangements, the despite mounting complaints from party workers, the leadership failed to heed the warning signs, mistakenly believing that the construction of the Ram temple, airport, and infrastructure projects would secure victory. Despite the ubiquitous presence of BJP flags, the ground reality painted a starkly different picture, with support for other parties gaining momentum.

Wildfire smoke may cause tens of thousands of premature deaths

Wildfire season got off to an early start in Northern California with the Corral Fire, which started burning grasslands in San Joaquin County on June 1 and grew to cover more than 50

square kilometers. A new modeling study estimates the health effects on the state's population due to plumes of smoke from fires like this one - not only in the first few days, but also after years of exposure. Researchers estimate that fine particulate matter pollution spewing from California wildfires from 2008 through 2018 was responsible for 52,500 to 55,700 premature deaths in the state. The estimated economic benefit of reducing that early mortality is \$432 billion to \$456 billion, the team reports

June 7 in Science Advances. The study finds "quite a considerable impact" from wildfire smoke exposure over time, says environmental health scientist Stephanie Cleland of Simon Fraser University in Burnaby, Canada, and the Vancouver Coastal Health Research Institute. Health impact assessments like this underscore the benefit of investments to build smoke resiliency, says Cleland, who wasn't involved in the study. Fine particulate matter, called PM2.5, describes air-borne particles of pollution that have a diameter of 2.5 micrometers or small borne particles of pollution that have a diameter of 2.5 micrometers or smaller. Once inhaled, these microscopic particles can travel all the way to the lungs' alveoli, the delicate air sacs surrounded by tiny blood vessels, where oxygen is exchanged for carbon dioxide. There's evidence that the particles can even enter the bloodstream.
