#### Arms and ammunition suspected to be airdropped recovered near LoC

Jammu: Security forces on Friday recovered arms and ammunition suspected to be airdropped near the Line of Control in Rajouri district of Jammu and Kashmir. Sources said security forces on the intervening night of Thursday-Friday fired a few rounds on noticing a quadcopter near the LoČ in the Jhangar area of Nowshera sector. Suspecting airdropping, the army troops launched the Cordon and Search Operation (CA-SO) in the area early morning on Friday. Sources said, "One pistol, 37 rounds, and two loaded magazines were recovered from the spot." The searches are being carried out in the area, they said.

The property (land) is situated at Dharmsal, Khari falling under Khasra No. 37 measuring 18 Marlas and under khasra No. 38 measuring 11 Marlas recorded in the name of the accused person who is absconding, he said. He said the accused is already wanted in cases registered against him un-der the Explosive Act, NDPS Act, Arms Act, UA(P) Act, and other relevant sections along with other associates.

#### Punjab VB arrests **Junior Engineer for** taking Rs 1 lakh bribe

Ân official spokesperson of the state VB said the accused was arrested based on a complaint lodged by Rashpal Singh, a resident of vil-lage Bhorli Kalan, Gurdaspur district. He further informed that the said complainant has approached the VB and alleged in his complaint, that the aforementioned JE had demanded Rs One lakh bribe for not reporting about complainant's Agricultural land as a part of illegal colony being examined by the accused.

As many as 16.83 crore new jobs have been created in the last six financial years from 2017-18 to 2023-24, Minister of State (MoS) for Labour and Employment Shobha Karandlaje informed the Parliament.

The total employment in the country registered a robust 35 per cent increase during this 6-year period from 47.5 crore in 2017-18 to 64.33 crore as of March 2024, the minister stated in a written reply to the Rajya Sabha.

The information is based on the latest KLEMS (K: Capital, L: Labour, E: Energy, M: Materials and S: Services) data of the RBI which provides employment trends at the all-India The minister said that the manu-

facturing sector (formal and informal entities) saw an increase of 85 lakh employment opportunities from 2017-18 to 2022-23.

In answer to another question on child labour, the minister said that



the government is pursuing a multi pronged strategy to eliminate the menace and has taken comprehensive measures which include legislative actions, rehabilitation strategy providing the right to free education and promoting general socio-eco nomic development.

# India to have first integrated agri-export facility

In a significant move to bolster India's agricultural export and import capabilities, the country's maiden integrated agri-export facility will be established at Jawaharlal Nehru Port in Mumbai, an official statement

Union Minister for Ports, Shipping, and Waterways Sarbananda Sonowal has approved the Jawahar-lal Nehru Port Authority (JNPA)'s project worth Rs. 284.19 Crore for the Development of Export-Import cum Domestic Agricultural Commodity-Based Processing and Storage Facility at JNPA on PPP Mode.

The JNPA is set to establish an allin-one state-of-the-art agricultural facility at the port, spanning 67,422 square meters. This pioneering facility will address inefficiencies in logistics, reduce multiple handlings,



and extend the shelf life of agricultural products, the statement said.

Expected benefits include better prices for agricultural goods, job creation, and overall growth in the agricultural sector. It will empower farmers and exporters, stimulate demand, and foster rural development, it said.

The facility will cater to exports of prominent items like non-basmati rice, maize, spices, onion, and wheat Additionally, as JNPA is a major gate way for frozen meat and marine products, the new facility will also benefit exporters of these products from regions distant from Mumbai.

Small exporters, in particular, will benefit from the port-based facility, improving their capabilities in logis tics, container booking, cold chain logistics, and export operations. The estimated export capacity increase includes a frozen store of 1800 met ric tonnes, a cold store of 5800 metric tonnes, and dry warehouses with a capacity of 12,000 metric tonnes for grains, cereals, and dry cargo.

This initiative aligns with the government's vision of empowering farmers and fostering rural develop ment, setting a precedent for future infrastructure projects that aim to support and enhance India's agricultural capabilities, the statement said
