Mumbai prepares for Durga Puja

Mumbai: The metropolis and its several lakh Bengali-speaking — have braced up for Durga Puja far away from West Bengal. The history of Durga Puja in Mumbai, the 'Urbs Prima in Indis', is more than a century old

Security forces recover suspected IED, rusted mine in Rajouri and Samba



Odisha Chief Minister Mohan Charan Majhi on Monday urged the Centre to deploy 12 companies of CAPF (Central Armed Police Forces) for a period of two years to prevent infiltration and eradicate Naxalites from the state in a time-bound manner.

Speaking at a meeting convened by Union Home Minister Amit Shah in Delhi on left-wing extremism, Ma-jhi also requested that the Central Forces not be withdrawn from the LWE (Left-Wing Extremism) areas. The Chief Minister said that to

counter the Naxalites, the state government has raised three battalions of ex-servicemen under the OSSF (Odisha Special Striking Force) and



that vacancies in other ranks of the police are being filled in a timebound manner.

He added that until the newly recruited forces are deployed on the

ground, there is an urgent need for effective area domination to prevent infiltration from Chhattisgarh and to enhance intelligence-based operations. Therefore, the central forces should be deployed in the area.

Majhi also requested that a dedicated helicopter be provided to the state, as uninterrupted helicopter services are a critical requirement for the movement of security forces maintenance of forward posts, and responding to emergencies in the LWE conflict zone.

The Chief Minister said that everyone acknowledges and appreciates the deadline given by Union Home Minister Amit Shah to end the Naxalite menace by March 2026.

Maha: HC grants AB to Shinde Sena leader

Mumbai: The Bombay High Court on Monday granted anticipatory bail to Eknath Shinde-led Shiv Sena leader Waman Mhatre in connection with an alleged offensive remark he made against a female journalist who was reporting on the Badlapur sexual abuse case.

Mhatre was booked under provisions of the Bharatiya Nyaya Sanhita (BNS) and also under the Scheduled Castes and Scheduled Tribes (Atrocities) Act for allegedly making derogatory remarks against the woman journalist during the protest against the sexual assault on two minor girls in Badlapur school by a male cleaning staff inside the school premises. While granting the bail, a single-judge bench of Justice Sandeep V Marne said, "I have allowed the application and granted anticipatory bail to the applicant."

Power to Lt Guv to nominate five members in Assembly 'unconstitutional', 'undemocratic': Karra

Jammu and Kashmir Congress President Tariq Hameed Kara on Monday termed the power to nominate five members in the new Assembly by the Lieutenant Governor as "unconstitutional" and "undemocratic."

Karra made these remarks in reply to a question about the power to nominate five members in the new Assembly by the Lieutenant Governor in Jammu and Kashmir.

"The constitution of India clearly mentions that even if the President of the country has to nominate members for the Rajya Sabha cannot do arbitrary and under the constitution he has to go through the advice of the government that is represented by the cabinet," Karra told media persons in Srinagar

Eight injured in gas cylinder explosion

Jalgaon: Eight people were injured, six of them seriously, following explosion of a household gas cylinder at Kasoda in Erandol taluka of the

The explosion occurred in the house of one Anil Puna Marathe, a farmer, at Kasoda in Erandol taluka, on Sunday evening due to leakage of gas after installation a new gas cylinder, causing a sudden fire. Due to the incident, Anil Marathe and his other family members ran out of the house, police said on Monday.

Upon hearing the news of inci-

dent, the neighbours gathered thinking that the farmer's cotton was on fire. When they went near the door of the house to check, there was a sudden big explosion of the gas cylinder in the house.

Investigate if laxity led to colliery blast: Suvendu

West Bengal Leader of the Opposition Suvendu Adhikari on Monday demanded a police investigation to find out if any laxity led to a blast at a colliery in Birbhum district in the morning in which he claimed seven people were killed.

He said among the seven people killed, four were tribals.

Adhikari said several people have been injured in the blast at Gangaramchak Mining Pvt Ltd Colliery in Bhadulia village area of Khayra-sole Block, under the Lokpur PS in Birbhum district.

LG Saxena criticises Delhi Gov for 'open manholes, heaps of garbage' in South Delhi



Delhi Lieutenant Governor (LG) Vinai Kumar Saxena on Monday criticised the Aam Aadmi Party-led government for the 'open manholes, heaps of garbage, and mismanagement of electrical wires' in the Rangpuri, Aya Nagar, and Jaunapur areas of South Delhi.

LG Saxena's statement followed his inspection of these areas on Sunday, during which he blamed the Delhi Government for the 'mismanagement' in

the capital, which has created hazardous conditions for residents. He remarked, "Yesterday evening, during the

inspection of Rangpuri, Aya Nagar, and Jauna-pur in South Delhi, following persistent re-quests from local residents, a shocking example of the failure and mismanagement of the Delhi Government was once again evident. The alarming situation, with a maze of electric



Thousands of people living here are deprived of basic amenities. There is encroachment, and garbage piles up in the narrow streets. Pits filled with drain and sewer water, and a haphazardly scattered network

of pipes make life miserable. Even today, essential services like sewage, drinking water, and proper roads remain unavailable in the nation's capital," he added.

The LG further attacked the Delhi government, highlighting issues such as 'lack of drainage and permanent water lines.

Due to the absence of proper drainage, people are living amid foul smells and diseases caused by waterlogging in densely populated areas like Rangpuri.

Two trainee SIs arrested in 2021 police recruitment exam paper leak case

The Special Operations Group (SOG) has arrested two trainee sub-inspectors (SIs) from the Rajasthan Police Academy (RPA) in connection with the alleged 2021 Rajasthan Police SI recruitment exam paper leak case, officials

said on Monday.

The arrested trainee SIs have been identified as Dinesh Kumar and Priyanka Kumari— both siblings and residents of Jalore district. They were produced in court and sent to police custody till October 11.

Their father, Bhagirath, is absconding, officials said. SOG ADG VK Singh said that trainee SIs Priyanka and her brother Dinesh, both natives of Jalore, have been arrested as part of the investigation in the case.

The duo used the leaked paper to pass the exam, and authorities were interrogating

According to officials, the siblings allegedly received the question paper through mafia member Bhupendra Saran's brother, Gopal Saran, a suspended sub-inspector in Jaipur. They were shown the exam paper in a car at



Gopal was selected as an SI in 2014 after

clearing the recruitment exam in 2011 In the same case, Santoshi, sister of Manju Bishnoi-who was arrested earlier from Barmer—has also been caught.

Chhammi Bai, alias Samita, allegedly trained and appeared for the exam as a dummy candidate. She has been involved in not only the SI recruitment exam but other exams as well. She is currently in police custody and on remand until October 10, officials said.
