Indian Army pays tributes to soldiers martyred in IED explosion

Jammu: Indian Jammu: Indian Army on Wednesday paid tributes to the soldiers martyred in an Improvised Explosive Device explosion on the Line of Control in Akhnoor sector. "In a solemn wreath-laying ceremony, #GOC @Whiteknight_IA laid a wreath at Air Force Station #Jammu to pay homage to #Bravehearts Captain Karamjit Singh Bakshi and Naik Mukesh Singh Manhas, who made the supreme sacrifice on February 11 in the highest traditions of the #IndianArmy, the White Knight Corps posted on X. An Army Captain and a Naik were killed in a suspected Improvised Explosive Device (IED) blast in Akhnoor sector during a fence patrol.

Three killed, 1 injured in multiple vehicle collision

Virudhunagar: Three people were killed and another grievously injured in a multiple-vehicle collision involving a motor-cycle, cargo vehicle and a truck at Agragarapatti village on the Sattur-Virudhunagar highway in this Southern district of Tamil Nadu on Wednesday. Police said the accident occurred, when the driver of a cement-laden truck suddenly stopped the vehicle after one of the tyres of the vehicle was burst. Two persons, identified as M.Selvan and D.Vinodh, who were riding a motorcycle lost control in which the twowheeler crashed into the rearside of the truck. A cargo vehicle ferrying fruits coming behind the motorcycle subsequently rammed into it, killing both Selvam and Vinodh on the spot.

1984 Anti Sikh riots: Court convicts former **Congress MP Sajjan Kumar in murder case**

The Rouse Avenue court convicted former Congress MP Sajjan Kumar in a 1984 Anti Sikh riots case.

This case is linked with the killing of father son duo in Saraswati Vihar area on November l, 1984. Sajjan Kumar is serving a life sentence in another anti Sikh riots case of Delhi Cantt.

Special judge Kaveri Baweja pronounced the judgement and con-victed Sajjan Kumar.

Sajjan Kumar was produced physically before the court. On January 31, the court had reserved the order after hearing additional submissions by the Public Prosecutor Manish Rawat.

This case is related to the killings of one Jaswant Singh and his son



Tarundeep Singh in Saraswati vihar area on November 1, 1984.

Advocate Anil Sharma had submitted that Sajjan Kumar's name was not their from very beginning, law of foreign land is not applicable in this case and there was a delay of 16 years in naming Sajjan Kumar by

the witness.

It was also submitted that a case in which Sajjan Kumar was Con-victed by the Delhi High Court is pending appeal before the Supreme court.

Advocate Anil Sharma had also referred to the case cited by the senior advocate HS Phoolka. He submitted that the law of the land will prevail even in the extraordinary situation and not the international law.

Additional Public Prosecutor Manish Rawat in rebuttal had submitted that the accused was not known to the victim. When she (a family members killed in the riots) became aware that who is Sajjan Kumar she named him in her statement.

Mumbai: A 40-year-old labourer was arrested in Goa by a team of Bandra Railway Police for allegedly issuing a threat to blow up the Chembur Police Station in Ñumbai, an official said here on Wednesday. According to details on Feb 9, a

hoax call was received on the Bandra Railway Police station's landline from a mobile phone, threatening that the Chembur station would be blown up.

According to the police, the caller's number was traced to Goa. A team of railway police was dispatched to Goa, and with the help of local police, they arrested a 40-yearold man working as a labourer in Goa.

Police said that during the probe it was revealed that the accused was under the influence of alcohol when he made the call.

HAL not in mission mode: Air Chief Marshal



Bengaluru (UNI) IAF) Chief Air Chief Marshal Amar Preet Singh has expressed concerns over Hindustan Aeronautics Limited (HAL), stating that he is not confident in its ability

to deliver on commitments, particularly regarding the production of the Tejas Mk1A fighter jets.

In an interaction with the HAL officials sitting in the cockpit, the IAF Chief said, "I can only tell you what our requirements and worries are. You have to alleviate those worries and make us more confident. At the moment, I am just not confident of HAL, which is a very wrong thing to happen.

Highlighting the delays in aircraft production, he remarked, "HAL is our own company. Even I have I find that HAL is just not in mission mode. I was promised that when I come here on February, 11 Tejas Mk1As would be ready. And not a single one is ready.'

Bengal: ED begins searches at 3 locations in relation to alleged ration distribution scam

Kolkata: The Enforcement Directorate (ED) on Wednesday raided at least three locations, including that of Howrah, in relation to alleged ration (PDS) scams across West Bengal, official sources said.

The ED, aided by the Central Paramilitary forces, began searches at the house and offices of one Parnendu Jana, a businessman, at Shyampur in Howrah in relation to the multi-crore rupees ration distribution scam during the Covid period. Sources said ED has been searching for the past four hours and questioning Shyampur, ED also began searches at two other locations - Jagatballavpur in Howrah district and Santoshpur in South 24 Parganas district.

Clashes erupt over hoarding dispute in Jharkhand's Koderma, 15 injured

A violent clash broke out between two groups in the Domchanch area of Jharkhand's Koderma district on Wednesday over the placement and removal of hoardings and banners near the Ravidas temple. The altercation quickly escalated into stone pelting, leaving at least 15 people, including three policemen, injured.

According to reports, tensions flared when a group of people began removing hoardings and posters that had been put up near the Ravidas temple. These banners were related to the ongoing construction of a Durga ort



confrontation.

Evewitnesses said that as the situation worsened, both sides engaged in heavy stone pelting, causing iniuries t severa injured were Domchanch Police Sta tion in-charge Omprakash and two other policemen, one of whom sustained a head injury.

638 stolen/lost mobile phones recovered

Eluru, AP: The Eluru district po-638 have recovered lice stolen/lost mobile phones worth Rs 76.56 lakh and handed over some of them to the owners. Superintendent of police Pratap Shiva Kishore here on Wednesday said that the CCS police, the Cyber Crime and the Law & Order police personnel jointly recovered stolen and lost mobile phones over the past three months. Using the district toll-free number and the Central Equipment Identity Register (CEIR) portal, a total of 638 mobile phones were recovered in the 14th phase, amounting to a total value of Rs 76,56,000.

PRL scientists discover new exoplanet, a dense sub-Saturn



The Scientists of the Physical Research Laboratory (PRL), Ahmedabad, have discovered new exoplanet, a dense sub-Saturn using PARAS-2 Spectrograph at Mt Abu Telescope.

In an update on Wednesday, IS-RO said the PRL scientists have discovered a new exoplanet, TOI-6038A b, a dense sub-Saturn size with a mass of 78.5 Earth masses and a radius of 6.41 Earth radii in a wide binary system.

The planet orbits a bright, metalrich F-type star every 5.83 days in a circular orbit.

"The TOI-6038A b lies in the transition region between Neptunelike and gas giant exoplanets, called as "Sub-Saturn," a category absent in our solar system, providing a



unique opportunity to study plane-tary formation and evolution", the Space Agency said.

This marks the second exoplanet discovery using the state-of-the-art PARAS-2 spectrograph attached to the 2.5-meter telescope at PRL's Mount Abu Observatory at Gurushikhar, Mt. Abu.

Furthermore, it is the fifth exoplanet detection using the com-bined efforts of the PARAS-1 and PARAS-2 spectrographs. It highlights India's growing ex-

pertise in advanced astronomical instrumentation, with the PARAS-2 spectrograph being the highest-res-olution stabilized radial velocity (RV) spectrograph in Asia.

Precise Radial-Velocity data from PARAS-2, which was used to measure the mass of the planet, along with high-spatial resolution speckle imaging from the PRL's 2.5-meter telescope, were thus absolutely crucial in validating the planetary nature of the transit signal and hence the discovery.

SC strikes down appointment of National **Commission for Homeopathy Chairperson**

New Delhi (UNI)

The Supreme Court on Wednesday struck down the appointment of Dr. Anil Khurana as Chairperson of the National Commission for Homeopathy, ruling that 'it was not in accordance with the law'. A bench comprising Justice Dipankar Datta and Justice Manmohan directed Dr Khurana to vacate the office within a week.

"The Respondent shall step down from the office of Chairperson forthwith. By forthwith, we mean a week from today to enable him to complete his assignment without taking any policy decisions involving finances," the Court stated.

The case stemmed from a writ petition filed before the Karnatāka



High Court, challenging the appointments of Dr Khurana as Chairperson and Dr K.R. Janardanan Nair as President of the Medical Assessment and Rating Board.

The petitioner, an applicant for both positions, argued that the ap-

pointments violated Section 4(2) and Section 19 of the National Commission for Homeopathy Act, 2020, which mandate a minimum of 20 years of experience, including at least 10 years in a leadership role.

A single-judge bench of the Kar-nataka High Court had ruled in favour of the petitioner, finding that Dr Khurana lacked the required leadership experience. However, a division bench later overturned this ruling on August 31, 2022.


Reinstating the single judge's ver-dict, the Supreme Court held: "We have given our reasons why we are holding that the selection and appointment of the 3rd Respondent is not under the law.

Mumbai Police issue notices to podcaster Ranveer Allahbadia

The Mumbai Police's Cyber cell has issued notices to podcaster Ranveer Allahbadia, comedian Samay Raina and others directing them to appear for questioning in connection with the ongoing probe related to an FIR registered against them for allegedly making obscene content and broadcasting it on Raina's India's Got Latent show, which sparked a huge controversy.

Confirming about issuing notices, Police sources on Wednesday said, Yesterday Cyber cell of the police had registered FIR invoking Section 67 of the Information Technology Act, among other sections, citing the alleged use of "obscene and foul language" during the show's six



episodes

The FIR names hosts, judges, par ticipants, and other artists associated with the program, all of whom were summoned for questioning. The Assam Police had on Monday

registered an FIR against five people, including Allahbadia and Raina.
