#### Five minors booked for sexually assaulting eight-year-old boy

New Delhi: An eight-year-old boy was allegedly sexually assaulted by minors in outer Delhi's Nareľa. As per the Delhi police, a PCR call was received on February 16, which alleged the commission of gang rape with a boy. After the inquiry, it was found that children aged (10 to 15) committed unnatural sex with a boy (8 years old) who resides near Dalmil Kurali of Narela in Delhi. As per the input, the incident took place on February 11 at the residence of one (Child in Conflict with Law). The mother of the eightyear-old victim filed the complaint in the police station against the accused. The mother of the victim alleged that when she went somewhere, the accused, five boys, aged between 10 and 15, living in their neighbourhood, assaulted her son.

### Body of girl recovered in Prayagraj

**Prayagraj:** The body of a girl who had come to take a bath in Maha Kumbh was found in the bathroom in the Jhunsi area of Prayagraj district here in Uttar Pradesh on Wednesday, police sources said. Police sources said that a youth and a girl from Delhi, claiming to be husband and wife, had rented a room to spend the night in the Azadnagar area under the Jhunsi area police station on Tuesday nigĥt. "There were other tenants in that house, and the bathroom was common," they said. Police sources said that on Wednesday morning when other tenants went to the bathroom, they recovered the body of the girl. The youth who had come with the girl had fled the same night after seeing the opportunity.

### HC adjourns hearing on Ekta Kapoor's petition to Sept 16

Phagwara: The Punjab and Haryana High Court has ad-journed hearing on a petition filed by film and television producer-director Ekta Kapoor concerning an over 11-year-old case registered against her in Jalandhar district for allegedly hurting the religious sentiments of the Valmiki community. The petition was listed before a bench headed by Justice Sanjiv Berry on Tuesday. The court adjourned the case to September 16. The case was registered by the police on August 16, 2013, and the petition was filed the next year. Kapoor, her mother Shobha Kapoor and four members of her production team involved with the serial Pavitra Rishta, and the Zee TV owner had been booked by the Nako-dar police station in 2013 for allegedly committing an offence under section 295-A of the Indian Penal Code (IPC) that deals with hurting of religious senti-

# Diya Kumari announces key infrastructure, irrigation, and governance reforms

Rajasthan Deputy Chief Minister and Finance Minister Diya Kumari on Wednesday presented the state's Budget 2025 in the Assembly, mak-ing several major announcements across various sectors.

In the irrigation sector, Diya Ku-

mari announced that 4 lakh farmers would benefit from new initiatives. The state has already commenced work worth Rs9,400 crore under the Ram Jal Setu Link Project (PK-ERCP), while tenders worth Rs12,400 crore have been finalized, and approvals for projects worth Rs12,807 crore have been granted.

Under this scheme, additional work worth Rs9,300 crore will be un-



dertaken. The government also announced the establishment of the Rajasthan Water Grid Corporation by upgrading the ERCP Corporation, which will oversee Rs4,000 crore worth of projects.

Furthermore, Rs1,250 crore will

be spent on drip and sprinkler irriga-tion systems covering 3.5 lakh

hectares, while 50,000 new ponds will be constructed. A subsidy of Rs900 crore has been allocated for a 20,000 km irrigation pipeline project.

In the power sector, the Deputy CM announced that 5 lakh new domestic household electricity connections and 5,000 new agriculture-re-lated connections would be provid-

On the infrastructure front, she declared the removal of the Bus Rapid Transit Service (BRTS) from Jaipur and the construction of nine new greenfield expressways. Additionally, ring roads will be developed in 15 cities. The Minister also announced the recruitment of 1050 new technical positions.

For governance reforms, the government will set up Jan Sunwai Kendras in every assembly constituency to address public griev-

Atal Gyan Kendras will be established in panchayats, starting with those with a population of over 3,000. A new Ambedkar Institute of Constitutional Studies and Research will be set up under Dr. Bhimrao Ambedkar Law University. MLA Jan Sunwai Kendra will be established in every Vidhan Sabha with Rs 10 lakh to solve the problems of the public. Also, each MLA will be provided with

The budget also included provisions for Agniveers, who will receive reservations in police, jail, forest, and fire services. Additionally, Rs1,000 crores have been allocated for the development of eight new districts. The salaries of representatives in panchayati raj institutions and urban local bodies will be increased by 10%.

# **Gujarat Congress MLAs protest against** deportation of Indian immigrants from US

Gujarat Congress MLAs gathered outside the State Assembly in Gandhinagar and shouted slogans like "Bharatiya ka ye apman nahi sahega this disrespect against the Indians). Recently, three illegal Indian immigrants belonging to Gujarat, who were deported from the US, were brought to Ahmedabad on Monday.

The third batch of 112 illegal deportees landed at Amritsar Airport on Sunday after US President Donald Trump's inauguration. On February 5, a US Air Force plane carrying the first batch of Indian citizens, who had allegedly migrated to the US illegally, arrived in Amritsar, Punjab.

Earlier on Saturday, Punjab Chief Minister Bhagwant Mann assured that the deportees would be treated properly and that all arrangements had been made. The Chief Minister said the deportees would stay in Amritsar for a few hours before being taken to their respective states.

## NIA arrests 3 more accused

Tuesday from Karnataka and Kerala. Vethan Laxman Tandel and Akshay Ravi Naik were picked up from

Uttara Kannada district in Karnataka while Abhilash PA was arrested from Kochi in Kerala, the NIA said. With these, the total arrests in the case have gone up to eight. The

agency said that "all the three arrested

accused were found to have been in

contact with Pakistan Intelligence Operatives (PIOs) through social media. "They were sharing sensitive information about Indian defence es-



tablishments at Karwar Naval Base and Kochi Naval Base, and were re ceiving money from PIOs in exchange of the information," said the NIA. Besides, Meer Balaj and Solan ki, NIA has chargesheeted another absconding PIO, identified as Alven Manmohan Surendra Panda and Amaan Salim Shaikh in the case, which it took over in June 2023.

The Chief Minister also assured them that peace and normalcy would be restored on the KIIT campus and urged Nepali students to return and resume their studies.

According to the Chief Minister's Office (CMŎ), Majhi held discussions with the two officials from the Nepalese Embassy at the State Guest

Odisha Health Minister Mukesh Mahaling, Higher Education Minister Suryabanshi Suraj, and Chief Secretary Manoj Ahuja were also present at the meeting, which focused on restoring normalcy at KI-

Additionally, Nepal's Foreign Minister, Dr. Arzu Rana Deuba, spoke with Survabanshi Suraj over the phone on Wednesday regarding the

Meanwhile, a high-level, threemember fact-finding team, led by Additional Chief Secretary (Home) Satyabrata Sahu, visited KIIT University and held discussions with university authorities and Nepali stu-

Sahu informed reporters that the



team would submit a detailed report on the death of the Nepali student and the incidents that followed.

On Tuesday, Commissionerate Police arrested three directors of KI-IT University and two security guards in connection with the unrest

following the student's suicide. The arrested officials include KIIT

University's HR Director Sibananda Mishra, Director of Administration Pratap Champati, and Director of Hostels Sudhir Rath.

Additionally, two security

guards, Ramakanta Nayak and Jogendra Behera, were arrested for allegedly assaulting Nepali students protesting the death of their fellow student.

All five were produced before a lo-

cal court, which granted them bail. On Monday, KIIT authorities had asked all Nepali students agitating over the death of their fellow student to vacate the hostel and return to

However, this decision was later withdrawn following mounting pressure and intervention from Nepalese Prime Minister KP Sharma Oli and the Odisha state government.

### Pandemonium in Odisha Assembly, House adjourned for day without much business

Bhubaneswar: The Odisha Assembly witnessed chaos as Opposition BJD and Congress members disrupted proceedings, forcing Speaker Surama Padhi to adjourn the house thrice during the day, eventually adjourning it for the day without transacting

much business. The house was first adjourned at 10:31 AM, just a minute after it convened for the day to take up the Question Hour, until 4 PM without transacting any business.

This came as BJD and Congress members stormed into the well of the house, shouting slogans against the government.
