Smack worth Rs 1.5 crore seized in East Champaran

Motihari: Police seized 7.5 Kg of Smack worth Rs 1.5 crore under Nakardeyi police station area in the East Champaran district of Bihar. Superintendent of Police (SP) Swarna Prabhat while confirming the report to UNI on Sunday said that the price of the seized Smack was estimated to be Rs 1.5 crores in the international market. At least ten smugglers were involved in the incident, he added. "Four of the ten accused involved in the incident have been identified", SP said adding that raids were being carried out to nab the smugglers. Close vigil was being maintained to check smuggling activities in the area, he informed.

Fire breaks out at paper mill in Gujarat's Kheda; no casualties reported

Kheda (Gujarat): A massive fire broke out at a paper mill in Varsola village, near Nadiad in Gujarat's Kheda district, on Sunday, engulfing large bundles of paper stored at the site. Upon receiving the alert, fire tenders and officials rushed to the spot and began efforts to bring the blaze under control. "We received information about a fire at a paper factory in Varsola village, about 12 km from Nadiad. We immediately reached the spot with two teams. On arrival, we found the fire was severe, so we called for additional fire tenders from Ahmedabad and Kheda," said Nadiad Chief Fire Superintendent Dixit Patel.

Notorious trafficker's main aide arrested

Jaipur: Police have arrested accused Vijay Anjana (36), who has been absconding for nearly 10 years in the case of drug trafficking, in Chhoti Sadri police station area of Pratapgarh district in Rajasthan. He is the main associate of Kamal Rana, a notorious smuggler who is in jail. Superintendent of Police Vineet Kumar Bansal said on Sunday that the police was looking for the accomplices of the jailed notorious smuggler Kamal Rana. FIR may be filed against Justice Verma

New Delhi: The discovery of a large amount of cash at the residence of Delhi High Court judge Justice Yashwant Verma has caused uproar. Following this incident, the Supreme Court has taken swift action. Chief Justice of India (CJI) Sanjiv Khanna has constituted a three-member committee to investigate the matter. The committee will be chaired by Justice Shil Nagu, Chief Justice of Punjab and Haryana High Court, with Justice GS Sandhawalia, Chief Justice of Himachal Pradesh High Court, and Justice Anu Shivraman from the Karnataka High Court also

While the case initially appears straightforward, the legal process is far more complex. Under current laws, criminal proceedings or an FIR





How can a Judge be removed?

If the in-house inquiry panel recommends removal, the CJI will ask the judge in question to resign or take voluntary retirement. If the judge refuses, impeachment proceedings may be initiated. The impeachment motion must be introduced in one of the houses of Parliament, with at least 100 MPs from the Lok Sabha and 50 MPs from the Rajya Sabha supporting the motion. If both houses approve the motion, the judge can be removed from office. To date, no High Court judge has been removed through impeach-

This entire process highlights the rigorous and complex procedures in place when dealing with allegations against a sitting judge, reflecting the importance of maintaining the integrity of the judicial system.

Conspiracy to trap and defame: Justice Yashwant



Delhi High Court judge Justice Yashwant Verma has denied the recovery of huge amounts of cash at his official residence. In a report by Delhi High Court Chief Justice DK Upadhyay released by the Supreme Court, Justice Verma claimed that the information about the alleged recovery of huge amounts of money at his official residence was a conspiracy to trap and defame (Justice Verma). In the 25-page report released on the apex court's website

(some parts of which are unclear due to black ink), Justice Verma said, Neither I nor any member of my family had ever stored any cash or currency in that storeroom (where the fire incident took place on the night of March 14, 2025)." He claimed that the entire incident is part of a recent sequence of events, including baseless allegations circulated on social media in December 2024.

If the CJI deems the allegations against the judge prima facie valid, he may advise the President of India to allow the police to file an FIR. Only after this step can further action be taken. However, if the judge is no longer in office, such approval is not

In-house procedure for action

In the 1995 case of Ravi Chandran Iyer vs. Justice AM Bhattacharya, the Supreme Court clarified that im-

peachment of a sitting judge should be pursued only in serious cases. The Court suggested an alternative process known as the "in-house procedure.'

Under this system, if the CJI receives a complaint against a judge, they may seek a response from the accused. If the CJI is not satisfied with the response and believes the matter warrants investigation, an inhouse inquiry panel is formed. This panel consists of two Chief Justices from other High Courts and one High Court judge.

Naxalites carried out IED blast, jawan narrowly escaped

Bijapur: Naxalites targeted security forces by detonating an IED on Bhopalpatnam National Highway-63 in Bijapur district of Chhattisgarh but the security forces not only escaped unhurt in this accident, but due to their alertness, a major accident was averted.

This incident took place near Gorla drain situated between Gorla Dudhera. After the explosion, Naxalites also fired on the soldiers, however, due to the alertness of the security forces, a major accident was averted. According to the information, this IED blast was done by the command system. The explosion created a crater about five feet deep on the road. During the incident, the pick-up vehicle of the security forces had moved ahead, due to which the soldiers were saved from major loss A soldier was injured due to the stones and debris thrown out by the impact of the explosion, whose treatment is going on in the hospital of Bhopalpatnam. After this incident in Madde police station area, the soldiers have increased their vigilance. Naxalites are frustrated due to continuous targeting and encounters by security forces, due to which they are plotting to continuously attack the soldiers. This is also increasing the challenges of the security forces.

Bus from Ayodhya to Nagpur overturns

Three dead, 14 injured in tragic accident; Fatal Road Accident at Ramanpur Valley

Jabalpur: A tragic road accident occurred early this morning when a passenger bus traveling from Ayodhya to Nagpur lost control and overturned at Ramanpur Valley, within the jurisdiction of the Bargi police station. The accident claimed the lives of three passengers, while 14 others sustained injuries. The sudden mishap caused chaos

at the scene, prompting local villagers to rush to the site to assist with rescue operations. They immediately informed the police, who arrived

The injured were rushed to a nearby hospital for treatment, and the bodies were sent to the medical facility for post-mortem.

According to Bargi Police Station in-charge Kamlesh Choriya, the bus, with registration number MH 14 LB 8718, was returning to Nagpur from Ayodhya when it lost control at around 4:00 AM and overturned in the Ramanpur Valley.

The bus was carrying 36 passen-



gers at the time of the accident. The impact caused panic among the passengers, but the police and local residents worked together to extricate them from the wreckage. Ambulance services quickly transported the injured to the hospital.

Sambhal violence: Jama Masjid Sadar chief Zafar Ali taken into custody

Zafar Ali, the chief of Jama Masjid Sadar and Shahi Mosque Committee, was taken into custody by Uttar Pradesh Police on Sunday for guestioning in connection with the violence that erupted in Sambhal on November 24 last year.

Ali was taken to Chandausi for a medical examination amid heavy se-

The development follows allegations of his involvement in the violence that broke out in Sambhal during a court-ordered survey of the Shahi Jama Masjid.

Earlier today, Zafar Ali and his son were summoned to the Sambhal Police Station for questioning. Security has been tightened outside the Chandausi Court, where both are to be presented as part of the legal pro-



ceedings in the case.

Circle Officer Anuj Chaudhary said, "There are no new arrangements made... Forces have been deployed to maintain peace... There is peace in the area..

The Uttar Pradesh Police's Special Investigation Team (SIT) had earlier filed a chargesheet of over 4,000 vember 24 Sambhal violence that erupted during the ASI's examination of the Mughal-era mosque.

The violence had resulted in the deaths of four individuals and injuries to several others, including officials and locals.

NIA chargesheets 4 Babbar Khalsa International terrorists

The National Investigation Agency (NIA) has chargesheeted four terror operatives of the Babbar Khalsa International (BKI) terrorist organisation in the 2024 Chandigarh grenade attack case, officials said on Sunday.

As per a release by the NIA, the

Chandigarh grenade attack

chargesheet filed before the Special NIA Court in Chandigarh includes Pakistan-based designated individual terrorist Harwinder Singh Sand-hu alias Rinda, and US-based Harpreet Singh alias Happy Passia.

The release notes that the two terrorists were the primary handlers and conspirators behind the attack. They had provided logistical support, terror funds, weapons, and ammunition to India based on-ground operatives in Chandigarh for execut-

ing the grenade attack. As per the release, the September 2024 attack was intended to target a

retired officer of the Punjab Police. "Investigations revealed that Rin-

da, along with Happy Passia, had orchestrated the conspiracy to strike terror among law enforcement officials and general public through the grenade attack, as part of the broader aim to promote BKI's terrorist agenda. They had recruited local operatives, namely Rohan Masih and Vishal Masih, who were tasked with carrying out the attack under their direct instructions," the agency said.

Rinda and Happy directed the other accused, Rohan Masih and Vishal Masih, to conduct reconnaissance on the target twice before hurling the grenade, investigations revealed.
