Shivpuri: Three people have died in a horrific road accident in Shiv-puri district of Madhya Pradesh. In this horrific accident, two brothers and a sister, a total of three people have died tragically.

On receiving the information of the accident, the police reached the spot and after registering a case, sent the body for postmortem and took the matter under investigation. It is said that all

three deceased were going to Jhansi, Uttar Pradesh by bike.

Actually the accident took place on Mahuar bridge on the four-lane highway of Karaira police station in Shivpuri district. A three-wheeler loading (cargo) vehicle hit the bike riders hard. In this accident, two brothers Ankit Rai (28) and his cousin Satvam Rai (20) and cousin Vaishnavi Rai (18) have died.

All three deceased were going to attend a program at a relative's place in Jhansi, UP, when they became victims of a terrible accident. The family is mourning the news of death in the accident. The family members are crying inconsolably. After the accident, the cargo driver abandoned the vehicle and fled from the spot.

dore to witness the Rang Panchami festivities were also robbed. Over 35 complaints have been filed at the MG Road Police Station, including incidents of stolen gold chains and expensive mobile phones.

One notable case involved NRI Deepesh Hemnani, who reported that his gold chain was stolen during the Gair. Several others faced similar thefts, with valuable items like gold chains, bracelets, and mobile phones going missing. The police have arrested six thieves so far, and multiple complaints are still being filed. To tackle the issue, special teams have been formed, and CCTV footage from all corners of the Gair is being analyzed.

Additionally, eight individuals were arrested for harassing women during the event. They were caught by the Crime Branch team for inappropriate behavior and lewd com-

las. The chain had been snatched from a 65-year-old man during the Gair. Authorities are intensifying their efforts, vowing to catch the re maining culprits soon.


### Cong Office Shops sealed over unpaid property tax dues

Indore: The Indore Municipal Corporation has sealed several shops at the Congress office, Gandhi Bhavan on Sunday due to non-payment of prop-erty tax. A sum of Rs 10 lakh in unpaid property tax was due on these shops. The Municipal Corporation's rev

enue department took action by locking up 10 shops at Gandhi Bȟavan. This action was taken after the property tax dues of Rs 10 lakh remained unpaid for an extended period. It is reported that the office bearers of Gandhi Bhavan have been neglecting to pay the property tax for a long time, despite receiving multiple notices from the corporation. However, no payments were made.

Today, Assistant Revenue Officer Mayur Patil, acting on the instructions of Čommissioner Shivam Verma, executed the sealing of the shops. Commissioner Shivam Verma emphasized that if the outstanding dues are not paid, the entire Gandhi Bhavan build-ing could face similar sealing action.

The case was filed by Sachin Rajak and Abhishek Tiwari, district president and member of the Indian National Student Organization (INSO), Jabalpur, respectively. They have alleged that Dr. Verma's appointment as a professor was



#### made in violation of the rules.

According to UGC guidelines, a candidate must have a Ph.D. degree followed by a minimum of 10 years of teaching experience to be eligible for the position of professor. Advocate Utkarsh Agrawal, representing the petitioners, ar-

gued that Dr. Verma received his Ph.D. on November 25, 2008, and the MPPSC advertised the professor's position on January 19, 2009. The application deadline was February 20, 2009, by which time the required 10 years of teaching expe-rience should have been completed.

The petitioners pointed out that in a previous case involving Sangeeta Barukar, MPPSC had declared that 10 years of teaching experience post-Ph.D. was essential for appointment to the professor's post, which was not the case with Dr. Verma.

The petitioners argue that if Dr. Verma's initial appointment as a professor was unlawful, his subsequent appointment as Vice Chan-cellor cannot be considered legal.

# **Plaster falls from School** roof in Maihar

## A female teacher seriously injured

Maihar: A tragic accident occurred on Saturday at a government primary school in the district. The plaster on the outer wall of the Karhiya Bijuriya Government Primary School building suddenly collapsed

A female teacher, Shashikala Tiwari, was seriously injured when the plaster fell on her as she was exiting the building. Fortunately, no students were nearby otherwise, it could have resulted in a major tragedy. The injured teacher was immediately rushed to the hospital for treatment

According to reports, Shashikala was walking outside the school building when the plaster from the ceiling fell on her. Other teachers at the school quickly assisted and took her to a hospital in Maihar, where she received first aid and was then referred to the Satna district hospital. Her condition is reported to be serious but stable.

This school had been in a dilapi dated condition for some time, but no repairs were carried out. District Education Officer T.P. Singh confirmed the incident and assured that all such deteriorating schools in the region are being identified, and nec essary repairs will be done soon There are nearly 3,000 government schools in Satna and Maihar, and around 600 of them are operating in poor conditions, lacking proper maintenance and boundary walls.

Shivpuri: A tragic road accident occurred on the Guna-Shivpuri four-lane highway in the Lukwasa police station area of Madhya Pradesh's Shivpuri district. spot, while Dr. Neelam Pandit (55) was taken to the district hospital in critical condition but succumbed to her injuries during treatment.

#### Four seriously injured, receiving medical care

The four other injured individuals— Dr. Uday Joshi (64), Dr. Subodh Pandit (62), Dr. Atul Acharya (55), and Dr. Seema Joshi (59)-are currently receiving medical attention at the hospital. Upon receiving news of the incident, the Lukwasa police and Purankhedi toll plaza ambulance teams arrived at the scene and quickly transported the victims to the hospital. Police have informed the families and are investigating the cause of the accident.

Raises questions on Power Distribution Company's negligence



Raisen: A tragic incident occurred in Sultanpur's Imliya village, where a tribal woman, identified as Suman, was electrocuted while heading to the fields for defecation. The 11 KV power line, hanging low over the fields, caused a fatal electric shock that resulted in her death on the spot. The shock was so severe that it set her body on fire.

Shockingly, Suman's body lay in the field for an hour before villagers discovered it, causing panic in the area. The incident has once again highlighted the negligence of the local power distribution company. Despite earlier complaints about the low-hanging wires, no action was taken, leading to this fatal accident.

The villagers are now demanding strict action against the company, blaming it for the tragedy. They argue that timely repairs could have prevented this incident. Following the incident, Sultanpur police arrived, seized the body, and began an investigation. They have registered a case and await the post-mortem report.

The death has caused widespread anger in the region, with residents calling for compensation for the family and accountability for the department's failure to address the dangerous wiring. This incident has underscored serious concerns about the region's electrical infrastructure and safety measures.



Gwalior: Police has arrested two criminals who broke into a businessman's house and beat up the fami-ly and looted them. Ťhe third criminal involved in the incident is still absconding. Police have also recovered some gold and silver jewellery from the criminals. three Actually,

criminals carried out a robbery at a businessman's house in Halwatkhana Soda Kuan of Gwalior police station area on March 18.

The businessman's wife Neetu Goyal had gone to the station with her son to pick up her daughter after locking the house on March 18. When she

returned home from the station, she saw that the locks were broken and three criminals were taking away 50 thousand rupees along with gold and silver jewellery kept in the house. When Neetu, daughter Prachi and son Kartik tried to stop the criminals, they pushed the daughter

The suspects had fled from the spot leaving their car behind.

Based on the mo-torcycle used in the incident, the police have arrested two criminals Jugunu alias Arif Khan and Farooq Khan and recovered some gold and silver jewellery. The police have

said that the remain-ing gold and silver jewellery and cash will be recovered from another absconding criminal Shakir Khan after his arrest.

The police are try-ing to uncover other thefts and robberies by interrogating the arrested criminals. The information was given by Suman Gur-jar, ASP Gwalior.

# assaults younger brother's wife

Kathegaon, (Dewas): In Dewas, a brotherin-law brutally beat his younger brother's wife over a trivial matter. The man assaulted her so much that the woman's bones broke. After this the injured woman had to be admitted to the hospital.

The case is of Sandalpur in Kathegaon po-lice station area. It is being told that a man attacked his sister-in-law with a shovel over irrigating the field. The woman was seriously injured in this incident on Saturday morning. The video of the incident has surfaced late at night.

At the time of the incident, Sunita Gurjar was working in the field with her son Sachin. Her brother-in-law Kailash Gurjar was also in the nearby field. Sunita told Kailash that there is only one motor between the two fields, so they can use water alternately. On this, Kailash first abused and then attacked with a shovel.

Son also got injured in the attack: Sunita's hand's bones were broken in the attack. He also suffered serious injuries on his head, back and stomach. Kailash slapped Sunita's son Sachin who came to his mother's rescue and he suffered injuries on his back and hand. The accused threatened to kill him if he spoke about water again.

## Life term for son and accomplice in mother's murder and robbery



Sagar: A court has sentenced a son and his friend to life imprisonment for the brutal murder of the son's mother, accompanied by theft. The Deputy Director of Public Prosecutions, Trilok Chand Billaur, provided this information. The incident occurred in the Sagaur police station area on April 24, 2019.

Motivated by greed, the son, in collaboration with his friend, murdered his elderly mother. The crime involved strangling her with a rope, mutilating her legs near the ankles, and stealing her silver bangles along with Rs 50,000. This heinous act was committed with the intent to rob. Following the police investigation, the case was presented to the first additional sessions judge. During the proceedings, the court found the accused, Ranjeet and Jitendra—both residents of Sagar—guilty of multiple charges, including robbery, murder, misleading police, and concealing stolen property. In addition to the life sentences, the court imposed a fine of Rs 4,000 on each of the convicted persons.

## Tiger Attack in BTR, Kills Shepherd, villagers angry

**Umaria:** A shepherd died in a tiger attack in Umaria, Madhya Umaria, Madhya Pradesh. Villagers are angry over this incident. Villagers have come out on the streets to protest. It is being said that a tigress with two cubs is present in the area. At present, top police and forest department officials are present on the

Jhabua: A major incident has unfolded in Petlawad, where a under-construction building collapsed on Thandla Road, behind a petrol pump. There are concerns that several people may be trapped under the debris. Unconfirmed reports suggest that two individuals have died in the tragic accident. The crucial question now arises: who authorized the construction of such a large building? Authorities are looking into the matter. Police teams have arrived at the scene with full force, and res-
