The ED added that the Gandhis were involved in money laundering not only when they received the crime proceeds, but also when they continued to hold the proceeds.

Meanwhile, the judge asked the ED to give a copy of its report to the complainant, Subramanian Swamy, the report sad. The agency recently filed its chargesheet after starting the investigation in 2021. According to Swamy's complaint, the Gandhis misappropriated funds by financing Young Indian to recover a debt of Rs 90.25 crore owed by AJL to the Congress party for just Rs 50 lakh.

The ED's investigation began in 2021 after a magistrate court took cognisance of Swamy's private complaint filed in June 2014. Swamy had alleged that the acquisition was made for merely Rs 50 lakh despite AJL's real estate assets being valued at over Rs 2,000 crore.

## India rejects Pak's allegations on terror attack in Balochistan

New Delhi: India on Wednesday rejected allegations of the terror attack on a school bus in Balochistan and said blaming India for its notoriety as the global epicentre of terrorism has become a "second trend" in Pakistan.

"India rejects the baseless allegations made by Pakistan regarding its involvement in the incident in Khuzdar earlier today," External Affairs Ministry spokesperson Randhir Jaiswal said in response to media queries on Pakistan's allegations. India mourns the loss of lives in all

such incidents. However, in order to divert atten-

tion from its reputation as the global hub of terrorism and hide its abject failures, it has become a second nature for Pakistan to blame India for all its internal issues.

Jaiswal said that this attempt to deceive the world is doomed to fail. In Pakistan, at least five children were killed in an attack on a school bus in Balochistan today.

## SC justifies inclusion of non-Muslims in Waqf boards

The Supreme Court on Wednesday continued hearing a batch of petitions challenging the constitutional validity of the Waqf (Amendment) Act, 2025, with Solicitor General (SG) Tushar Mehta defending the Central government's stance before a bench of Chief Justice of India (CJI) B R Gavai and Justice Augustine George

## Waqf law hearing Day 2

Mehta asserted that waqf, though rooted in Islamic tradition, is not an essential religious practice under Islam, and that waqf boards perform secular administrative functions.

Therefore, he argued, the inclusion of non-Muslims in such boards is permissible and constitutional.

"Waqf is an Islamic concept. But it is not an essential part of Islam. Charity exists in every religion, inchains exists in every religion, including Hinduism and Christianity, but the Supreme Court has ruled that charity is not an essential religious practice.



Similarly, managing waqf properties, ensuring proper accounts and audits, all are secular in nature," Mehta submitted.

He further clarified that having a maximum of two non-Muslim members on waqf boards does not affect the religious character of waqf, since these boards do not interfere with religious activities.

The petitions, including those filed by Congress MP Mohammad Jawed and AIMIM MP Asaduddin Owaisi, challenge the amendment on the grounds that it violates the Muslim community's right under Article 26 to manage its religious affairs.

## **SC** grants anticipatory bail to ex-IAS officer Puja Khedkar



Court Wednesday granted anticipatory bail to former IAS pro-bationer Puja

Khedkar, who is facing serious allegations of submitting forged OBC and PwBD (Persons with Benchmark Disabilities) certificates to clear the Union Public Service Commission (UPSC) Civil Services Examination. A Bench comprising Justice B.V. Nagarathna and Justice Satish Chandra Sharma allowed the criminal appeal filed by Khedkar challenging the Delhi High Court's earlier denial of anticipatory bail. The Court made permanent the interim protection from arrest that had been granted to Khedkar in January.

## Donald Trump proposes 175 billion Dollar missile shield against incoming missiles

Washington (UNI)

Citing missile attack as the "most catastrophic threat" US President Donald Trump on Wednesday announced a 175 billion Dollar a multilayered missile shield to protect United States from advanced missile attacks. The missile shield called the 'Golden Dome' will be operational from January 2029. It will detect missile launches through satellites, and command systems powered by Artificial Intelligence,

The decision seemingly prompted by the recent success of \$-400 air defence missile system used by India against Pakistani drones and missiles in Operation Sindoor, will target incoming drones and hypersonic



missiles from launch to hitting the target. Defence Secretary Pete Hegseth said the system will defend against both conventional and nuclear threats. The project represents a substantial evolution from what was initially announced as the "Iron Dome for America" in the administration's first week, before being renamed "Golden Dome" by the Pentagon in February, possibly due to trademark concerns with Israel's existing Iron Dome system.

Guetlein previously served as the vice chief of space operations with the US Space Force and has extensive experience in missile defense and space-based capabilities.

In March, Guetlein described the project's scope, calling it "on the order of magnitude of the Manhattan Project" and saying it would "take concerted effort from the very top of our government" and "national will to bring all this together.'
