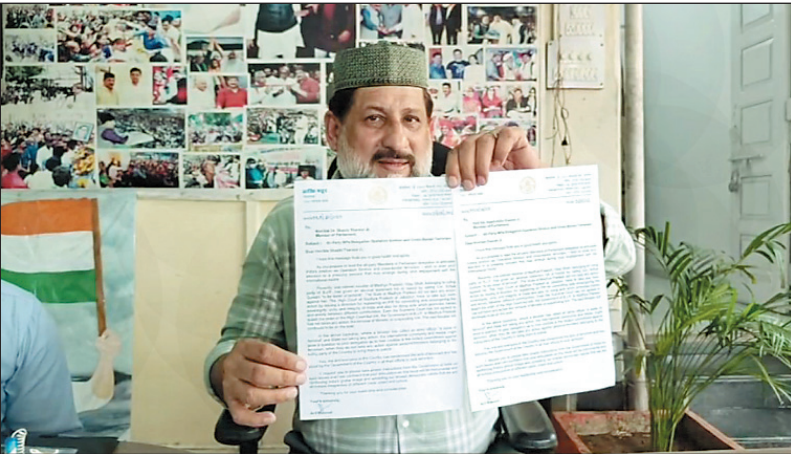


‘Operation Sindoor’ sparks political letters

● **MLA Arif Masood sends letter to delegation going abroad**

Bhopal: Amidst the ongoing debate surrounding Operation Sindoor, Congress MLA Arif Masood from Bhopal has written a letter to the delegation of Indian MPs, set to represent the nation abroad and clarify India's stance. Masood's letter raises serious questions about alleged derogatory remarks made by Madhya Pradesh Cabinet Minister Vijay Shah against Colonel Sophia Qureshi and the lack of action by the ruling party.

In his letter, Masood points out that while the delegation is preparing to represent India on international forums, they must be ready to answer any questions regarding the government's inaction on remarks made by a minister from the ruling BJP. Masood urged the delegation to take this issue up with the Indian government and seek



clarification on why no action has been taken against the minister.

Appeal to Shashi Tharoor and Asaduddin Owaisi

Masood's letter specifically addresses Shashi Tharoor and Asaduddin Owaisi, who are

preparing to lead the cross-party delegation on Operation Sindoor and cross-border terrorism. He writes, "I urge you to be mindful of an alarming issue that may come up during your discussions with the international media. Recently, Vijay Shah, a BJP minister from Mad-

hya Pradesh, called Colonel Sophia Qureshi the 'sister of a terrorist'—a hateful, derogatory statement. Despite this, no action has been taken by the state government."

Masood further emphasized that this incident could raise questions about India's commitment to fighting terrorism when senior figures from the ruling party face no accountability for their inflammatory remarks.

Request for guidance from Indian Government

Masood concluded his letter by requesting that the delegation seek proper directives from the Indian government on such sensitive issues. He expressed confidence that their response would strengthen India's global image and reinforce the country's commitment to upholding democratic values, irrespective of caste, religion, or culture.

BJP committed to eradicating Naxalism from India: VD Sharma

Bhopal: Madhya Pradesh BJP President Vishnu Dutt Sharma on Tuesday reiterated the party's unwavering commitment to eradicating Naxalism from the country. He praised the efforts led by Prime Minister Narendra Modi and guided by Union Home Minister Amit Shah, saying that security forces across India are working with full resolve to eliminate the Naxalite threat.

Responding to ongoing anti-Naxal operations in Madhya Pradesh and Chhattisgarh, Sharma highlighted Shah's recent statement that Naxalite activity is now limited to just six districts nationwide. He emphasized that the Home Minister has set a target to completely wipe out Naxalism by March 2026, and that under BJP governance, this mission is being actively pursued.

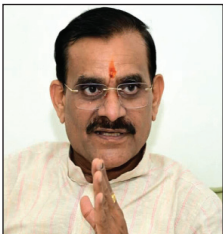
In Madhya Pradesh, Sharma noted, Chief Minister Dr. Mohan Ya-

day's administration is taking aggressive action against Naxal elements, particularly in Balaghat district, where recent intelligence indicated some rebel activity. Security forces launched an operation near Bilalkasa village, tightening the

noose around Naxal operatives. He expressed strong confidence that Naxalism will be eliminated from the state well before the national deadline.

Sharma also pointed to major successes in Chhattisgarh, where over two dozen Naxalites were reportedly neutralized in an encounter in the Abujhmad forests, including a top militant carrying a bounty of over ₹1 crore.

He concluded by asserting that under PM Modi's leadership, India's borders and internal security are stronger than ever, and the government's resolve to fulfill its promises remains steadfast.



Hospitals should be made patient friendly: Collector

Bhopal: District Health Committee and Task Force meeting was held at the Collector's office on Wednesday to review health programs under the chairmanship of Collector Mr. Kaushendra Vikram Singh. In the meeting, Collector said that hospitals should be made patient friendly, so that the patients coming there do not face any problem in treatment. Municipal Corporation and Health Department were instructed to work jointly to expedite the work of making

Ayushman cards for citizens above 70 years of age. Collector praised the outreach activities being done to provide health services to the beneficiaries in Bhopal district. He said that Sanjeevani Clinic should be further strengthened to reduce the OPD load on big hospitals.

It was told in the meeting that 77 gram panchayats of the district have been declared TB free under the National Tuberculosis Eradication Program. Under the infant vaccination

program, MR 1 is 97% and MR 2 is 92%. Complete vaccination is 110 percent. Special newborn care units are being operated in Jaiprakash District Hospital and Dr. Kailashnath Kajfu Hospital in the district. 1036 children have been admitted in these units last year. During the same period, 785 newborn children have been admitted in the Newborn Stabilization Unit in Civil Hospital Bairagarh, Civil Hospital Berasia, Community Health Center Kolar.

The Indore Special Bench of Hon'ble NCLT has passed the order upon Co. Appeal/21(MP) of 2024 dated 13th May, 2025 u/s 252(3) of Companies Act, 2013 in the matter of Anantashri Engineering India Private Limited which was struck off from Registrar of Companies, Gwalior MP on 28.01.2008 as published in the Official Gazette on 10.05.2008, due to non-compliance with statutory filing obligations.

The order for company restoration was passed on ground that the company was not operational due to delays in securing the industrial plot, but highlight their persistent efforts since 1998 to obtain the land, a prerequisite for business activities. The High Court's directive and subsequent administrative orders confirm the company's ongoing engagement with authorities, culminating in a directive to revive the company for plot allotment.

The Order Hon'ble NCLT provides for restoration of name of company in register of companies maintained by the Registrar of Companies, Gwalior, Madhya Pradesh within 30 days of this order and its status shall be changed from "Strike Off" to "Active and directed Registrar of Companies, Gwalior, Madhya Pradesh to update director's details on the MCA portal as per Form No. 32 to ensure accurate records post-restoration subject to payment of cost of Rs.10,00,000/- (Rupees Ten Lakh) toward the cost for revival of the company.
