Double tragedy strikes Madhya Pradesh

Five women dead, multiple injured in separate road crashes in Gwalior and Katni



Bhopal: A day of profound sorrow unfolded across Madhya Pradesh as two separate and devastating road accidents claimed the lives of five women and left multiple others seriously injured. Both incidents, one in Katni and another in Gwalior, occurred today, sending shockwaves through the respective communities.

In Katni, a horrific car crash resulted in the deaths of three women from the same family and left five others critically injured. The tragic incident occurred in the Dhimerkheda police



station area when the Barman family was returning from a 'Chowk' ceremony. Their fourwheeler lost control near the Khamtara petrol pump, approximately 3 kilometers from the police station, and overturned. The impact was so severe that Shivani Barman (35), Phoolbai Barman (40), and Rani Barman (50) succumbed to their injuries at the scene. Onlookers rushed to the wreckage, bravely extracting the five injured, who were immediately transported to the Umaria Pan health center for urgent medical

treatment. The deceased were residents of Khamtara village, and the news has cast a pall of grief over the community. Local police have launched an investigation into the full circumstances surrounding the accident.

Meanwhile, in Gwalior, a separate and equally devastating hit-and-run accident claimed the lives of two women - a mother-in-law and her daughter-in-law - and left the husband critically injured. The incident occurred in the Jhansi Road police station area when the family, traveling on a motorcycle from Bhind to Gwalior, was violently struck by an unidentified vehicle near Poddar School. The driver of the unknown vehicle fled the scene after the collision. Shanti Devi and her daughter-in-law, Malti Shakya, died instantly. The husband sustained severe injuries and is currently undergoing treatment at . Jaya Arogya Hospital. Police swiftly arrived at the site, registering a case and initiating an investigation. The bodies of the deceased have been sent for post-mortem examination. Authorities are currently scouring CCTV footage from the vicinity to identify and apprehend the hit-and-run driver responsible for this tragedy.

Teenager's murder exposed

murder of a teenager has come to light. A 13-year-old girl named Madhu was strangled to death by her stepmother, Sangeeta, due to disputes over household chores. Following the incident on May 18, her father, Balaram alias Balu Panwar, attempted to conceal the crime by cremating her body and falsely claiming that she had died from electric shock The case took a turn when local children recorded a video of the incident, capturing evidence of strangulation

cremation. This footage prompted the police to investigate further. Despite the initial lack of physical evidence due to the cremation, the video led to the interrogation of both Sangeeta and Balu, ultimately reveal ing the truth behind Madhu's death SĎOP Bhavishya Bhaskar confirmed that Sangeeta had killed Madhu due to domestic disputes, and Balu's ac tions to mislead the authorities were also uncovered. Fraudulent land sale shocks Shivpuri

Woman seeks justice

Shivpuri: A distressing case of land usurpation has emerged from Shivpuri district in Madhya Pradesh, where a widow's property was sald where a widow's property was sold under fraudulent circumstances us-ing a fake Aadhar card. The victim, Kalavati, a resident of Karera tehsil, claims that her land, valued at Rs 20 lakh, was illicitly sold for just Rs 5 lakh by land mafias who manipulated the registration process. Kalavati approached the District Superintendent of Police with her lawyer, alleging that officials at the Pichor Sub Registrar Office facilitated the fraudulent sale. She has called for justice, expressing desperation and even threatening self-harm if her plight is not ad-dressed. The situation has drawn at-tention from Union Minister and regional MP Jyotiraditya Scindia, who has urged the district administration



to take stringent action against the perpetrators. According to Kalavati's lawyer, land mafias in Shivpuri are notorious for executing such scams by using fake documents to complete property registrations. In this instance, the fraud involved creating a counterfeit Aadhar card for a woman named Sabo, who impersonated Kalavati during the registration

process, despite a significant age dif ference—Sabo being only 40 while Kalavati is over 60. The Sub Registrar Officer and staff at the Pichor office are now under scrutiny, along with the lawyer who facilitated the registry The administration has promised to investigate the matter thoroughly and ensure that justice is served to the ag grieved widow.

Crucial Airport file vanishes

Key to land scam feared lost

Satna: A massive, over 300-page file containing vital documents related to the Satna airport has mysteriously gone missing, sparking concerns of a deliberate cover-up. According to a retired Deputy Collector who previously served in the Satna Revenue Department, this crucial file could expose a "major scam" concerning the airport's land. The retired official recalls that in August 1997, this voluminous file was requested by the Rewa Divisional Commissioner's court in connection with a specific case. "I remember it was August because Republic Day celebrations were just a few days away," he stated. The file, he explained, detailed the illegal allocation of Satna aerodrome land and held complete records of land acquired for the airport, including approximately 50 pages of acquisition documents. Furthermore, it contained not only the "Ittalabi Register" from the Vindhya Pradesh era but also subsequent full records.

The file, estimated to be at least 300 pages thick, was sent to the Commissioner's office. Since then, it has not been seen in Satna, prompting fears that its disappearance is no accident and could be shielding significant irregularities. Scrutinizing records from August 1997 could pinpoint the exact date the file was dis-

Electric scooter inferno engulfs multiple vehicles

Indore: Panic erupted in the Maliarganj police station's Daliya Patti area this Wednesday afternoon when an electric scooter suddenly burst into flames. The fire rapidly spread, engulfing two nearby motorcycles, a moped, and even a car, whose front section was severely damaged. The blaze also charred the shutter and electrical board of an adjacent grain shop, leading to chaos and significant material loss. According to Maliarganj Police Station In-Charge Virendra Singh Kushwah, preliminary investigations point to the electric scooter as the origin of the fire. The incident occurred around 3 PM in front of a grain shop located in Lane Number 2. Eyewitnesses reported seeing smoke emanating from the scooter before it

The quack doctor administered incorrect medication to the child, who was suffering from a fever, leading to fatal consequences. In response to this incident, the health department has established an in vestigation team tasked with submitting a report promptly. The incident occurred in Udhwa village, where the person operating as a quack doctor is identified as Pappu Baghel. Reports indicate that the 8-year-old child was suffering from malaria accompanied by a high fever. The quack began treatment at 10 AM, initially giving the child a syrup. When the fever persisted, he administered another syrup. Unfortunately, the child's condition worsened, and he passed away

Nine-year-old boy falls victim to crocodile attack

The jolts were primarily felt in the Chinchda region of Betul district. Officials from the Seismology Center confirmed the event, stating the earthquake occurred at approximately 2:59 AM on Wednesday. 38 quintals of marijuana abandoned in Shahdol field

Smugglers flee

Shahdol: In a dramatic turn of events, Shahdol police uncovered 38 quintals of marijuana abandoned in a field, valued at an astounding Rs 3 crore. The haul, thought to be left behind by smugglers in a hasty escape, highlights a growing concern over illegal drug trade in the region. The discovery was made in Ğirai Khurd village, within the jurisdiction of Jaisinghnagar police station, when officers stumbled upon several sacks of ganja scattered across a field near a forest area. Acting on a tip-off, authorities seized the bags, weighing between 36 and 38 quintals. The police suspect that the smugglers, alerted to an impending police operation, abandoned their cargo and fled before authorities arrived. Superintendent of Police Ramji Srivastava expressed concern over the widespread nature of the illegal marijuana trade in the district, signaling that this seizure could be part of a much larger trafficking operation. Investigators are exploring possible links to broader networks with suspicions that the illegal trade may involve local households and extend across neighboring states. A case under the Narcotic Drugs and Psychotropic Substances (NDPS) Act has been filed, and the police have launched an investiga tion to track down those responsible for this massive narcotics haul This marks the first significant recovery of ganja in Shahdol, raising alarms about the scale of the issue

The couple had reportedly made plans to marry, and the wedding was scheduled for May 15, with all preparations made by the bride's family. On the day of the wedding, the mandap was beautifully decorated, guests were eagerly waiting, but the groom never arrived. As time passed and frustration grew, the distressed bride, still adorned with henna on her hands, took the matter to the Bhagwa police station to file a complaint against the groom. The woman claims that their relationship, which included physical intimacy, had been a prelude to marriage. However, she alleges that for the past five months, the man had exploited her under the guise of their upcoming wedding.

Shocking video takes social media by storm

- Woman strips husband on street in Indore
- Beats him with slippers
- Viewers say "This is too much!"

Indore: A startling video from Indore's Lasudia area has taken social media by storm, showing a woman publicly stripping a man and beating him with slippers in the middle of the road. The woman claims to be the man's wife, though no formal complaint has been filed with the police as of now. In the viral footage, the woman is seen pulling off the man's shirt on a busy street before furiously thrashing him with her slippers. At one point, she places her foot on his chest and continues to hit his face. Onlookers



tried to intervene and stop the assault, but the woman remained unrelenting. The situation escalated as she eventually removed his pants as well, leaving the man humiliated and partially undressed in public. Passersby captured the entire incident on video, which has since gone viral and sparked widespread outrage and disbelief online. Though the woman identifies herself as the man's wife, the reason behind the altercation remains unclear. With no police complaint filed so far, authorities have not initiated any legal action. Social media users, however, are expressing shock and condemnation, with many calling the incident a "new low" in public disputes.
