

Bhopal to implement policy for E-Rickshaws

► MP meets Collector, BMC Commissioner to tackle traffic congestion

Bhopal: The proliferation of e-rickshaws is causing significant traffic bottlenecks across Bhopal. To address this growing concern and improve the city's traffic flow, Bhopal MP Alok Sharma convened a meeting on Wednesday with Collector Kaushalendra Vikram Singh, Police Commissioner Harinarayan Chari Mishra, and Municipal Commissioner Harendra Narayan.

MP Sharma highlighted the core issue: "The absence of a clear policy for e-rickshaw operations leads to them being parked haphazardly on roads. Their slow speed further impedes vehicle movement, creating significant traffic jams." He emphasized that this congestion particularly affects main city routes, making it difficult for people to reach the airport and railway stations on time. To combat this, a comprehensive policy for e-rick-

shaw operation will be formulated.

Directives issued to remove dilapidated vehicles and clear footpaths

During the meeting, MP Sharma also discussed the problem of abandoned, dilapidated vehicles cluttering city roads. In response, the Collector instructed all present Sub-Divisional Magistrates (SDMs) to establish trenching yards in their respective areas and initiate a 15-day campaign, starting June 20th, to remove these vehicles from the roads.

Sharma further pointed out to the Collector and Commissioner that footpaths, meant for pedestri-



ans, are often encroached upon by vegetable vendors, fruit stalls, and other illegal structures, even extending over municipal drains. He stressed the need to remove these encroachments to facilitate smoother traffic flow, a point on which the Collector concurred. An encroachment demolition squad will be formed under the Collector's directives, headed by an Additional District Magistrate (ADM). This specialized team will include police Additional Deputy Commissioners, Municipal Corporation Additional or Deputy Commissioners, relevant SDMs, police ACPs, and Station House Officers.

Congress alleges RSS activity in tribal areas

Bhopal: In a scathing press conference, Congress leaders have heavily criticized the state government regarding the plight of tribal communities and the issue of land titles. Leader of Opposition Umang Singhar, former Union Minister Arun Yadav, and CWC Member Kamleshwar Patel jointly addressed the media.

"Politics of Religion instead of development": Umang Singhar asserted, "The RSS is actively operating in tribal areas, and there is talk of religious conversions happening there. Tribals have traditionally worshipped the sun, trees, plants, and animals, but the BJP is attempting to introduce the politics of religion into these regions." He further accused the government of prioritizing religious politics over development, claiming that "land is being arbitrarily distributed in tribal areas."

Tribal lands are being given to others. Three lakh land titles belonging to tribals and other communities have been canceled." Singhar highlighted a stark contrast: "The Kamal Nath government distributed 3.25 lakh land titles, but as soon as the BJP came to power, they immediately halted this."

Massive protest threatened in Nepanagar: Singhar also revealed, "In Nepanagar, 8,000 land titles have been canceled without prior notice

or consultation with the beneficiaries." He alleged corruption, stating, "Forest guards are taking Rs 10,000 and facilitating illegal logging. Tribals never cut down forests; there should be an investigation into this deforestation." He emphasized the illegality of the cancellations, asserting, "Land titles cannot be snatched from people who have been occupying the land for 40 years. The government is even unwilling to obtain satellite images." Singhar claimed that tribal lands are being reallocated to BJP affiliates, with homes being demolished and crops destroyed by tractors. He issued an ultimatum: "If the government does not take action within 15 days, there will be a massive protest in Nepanagar."

Half a million applications pending;

Arun Yadav highlighted the broader issue, stating, "Fifty-year-old land titles are being canceled. Land is not being transferred to the children of these families. Tribals are continuously demanding land titles, but they are not being issued. Today, 6.5 lakh applications are still pending." He warned, "If these demands are not met, Congress will launch a major agitation."

Corporate interests eyed: Kamleshwar Patel weighed in, asserting, "Gram Sabha rules are being disregarded. The PESA Act is also being violated. The resources of the tribal community are being eyed by some big industrialist. The government is acting in accordance with those interests."

Crucially, the squad will also be accompanied by a mobile court and a magistrate. A detailed policy for this initiative is currently being drafted.

Solving left-turn challenges and parking issues

To alleviate the persistent left-turn problems at major city intersections, an immediate decision was made to remove two specific rotaries: Nehru Nagar Square and the "Saade Das Number" rotary. A comprehensive plan will be developed to address left-turn issues at all major intersections across Bhopal in the coming months, with Public Works Department (PWD) and Municipal Corporation officials tasked with its creation.

MP Sharma also raised concerns about vehicles being parked for months in municipal parking lots, stressing that definite time limits for parking should be established.

Rahul Gandhi's birthday celebrated with milk ablution in MP

► BJP cries "Sycophancy"

Bhopal: Congress leaders in Bhopal marked Rahul Gandhi's birthday on June 19th with a "Dughabhishek" (milk ablution) of his poster, followed by a cake-cutting ceremony. The unique celebration was purportedly held to commemorate the clearing of the path for a caste-based census, a key issue for the Congress. However, the Bharatiya Janata Party (BJP) launched a scathing attack, labeling the event as blatant sycophancy.

Congress workers gathered at Board Office Square in Bhopal to perform the milk ritual on a poster of the newly appointed Leader of Opposition in the Lok Sabha, Rahul Gandhi. Following this, a birthday cake was cut. Congress leaders present stat-

Decision reserved in PCC Chief Jitu Patwari

► High Court petition filed challenging FIRs

Jabalpur: The Madhya Pradesh High Court has reserved its decision in the case involving Madhya Pradesh Congress Committee (PCC) Chief Jitu Patwari. The court concluded hearings on two separate petitions filed by Patwari, challenging First Information Reports (FIRs) registered against him in two different police stations.

The core of the matter revolves around allegations that Patwari revealed the identity of a rape victim and made derogatory remarks against a former minister in Madhya Pradesh. FIRs were lodged against him in both instances. The first FIR was filed in Jhabua for al-



legedly exposing the identity of a tribal rape victim.

Second FIR Under ST-SC Act in Dabra

The second FIR was registered in Dabra Gwalior, concerning comments Patwari made about former minister Imarti Devi. Patwari had reportedly told the media that "Imarti Devi's charm has faded." This led to an FIR being filed against him under the Scheduled Tribes and Scheduled Castes (Prevention of Atrocities) Act in Dabra police station in 2024. Justice Sanjay Dwivedi's bench has completed the hearing, and the judgment is now awaited.

CM Yadav pays tribute to journalism pioneer Pt. Madhavrao Sapre on birth anniversary

Bhopal: Madhya Pradesh Chief Minister Dr. Mohan Yadav today paid homage to Pandit Madhavrao Sapre, a revered figure from Madhya Pradesh's soil, a pioneer of Hindi journalism, and a freedom fighter, on his birth anniversary. Dr. Yadav lauded Sapre's invaluable contributions to journalism, noting his dedicated work on the monthly magazine Chhattisgarh Mitra, and for Hind Kesari and Karmveer. "His seminal work, 'Ek Tokri Bhar Mitti' (A Basketful of Earth), holds the distinction of being the first Hindi short story, which profoundly reshaped the literary landscape," Dr. Yadav stated. "Pandit Madhavrao Sapre's immense contributions will never be forgotten."
