### RML Hospital, Delhi gets new MS and Director

New Delhi: The Union Ministry of Health and Family Welfare on Thursday announced appointment of consultant (pediatrics) Dr Vivek Diwan as the new Medical Superintendent (MS) of the ABVIMS and RML Hospital in the national capital. Dr Diwan replaces Dr Arti Maria, a consultant (pediatrics) who was officiating the MS post for the last few months. At the same time, the Government has also appointed Dr Ashok Kumar, Director Professor (Obstetrics and Gynecology) as director of the Hospital, as per an officer order.

### **Bosiram Siram** appointed as new chief of Arunachal Cong

The appointment was approved by Congress president Mallikarjun Kharge. Siram, who previously served as the working president of the APCC, had contested the 2024 Lok Sabha elections from the Arunachal East constituency on a Congress ticket but was unsuccessful

### BJP MP Abhijit Gangopadhyay to be airlifted to Delhi for treatment

Kolkata: BJP MP and former Calcutta High Court judge Abhijit taken to Dum Dum Airport to be airlifted to AIIMS, New Delhi, amid growing concerns over his critical health condition. Hospital authorities confirmed on Wednesday that while his health has remained stable, the crisis is far from over. "We felt that the situation is not very good. If taken to Delhi AIIMS, we hope the doctors there will be able to provide even better treatment. We hope he recovers quickly," central minister and state BJP president Sukanta Majumdar said.

### ED raids multiple locations in Ranchi, Patna in NEET paper leak case

Ranchi: The Enforcement Directorate (ED) conducted raids at multiple locations in Ranchi and Patna on Thursday in connection with the NEET paper leak case. The ED team searched premises in Ranchi's Bariyatu and several locations in Patna. The raids were focused on the relatives of Sanjeev Mukhiya, the alleged mastermind in the NEET paper leak case, who had been arrested in connection with the scam. The ED had been investigating money laundering aspects of the case, following a case registered by the CBI.

"With this pioneering work, Filip Vezdin became one of the first European scientists to seriously devote himself to Indian languages and culture. At the same time, this is also a symbol of the early cultural ties between Croatia and India.

"As part of the gift exchange, I also presented a book "Croatia & India, Bilateral Navigator for Diplomats and Business" by Croatian diplomat Dr. Siniša Grgic - which provides a unique and comprehensive comparative overview of our two countries and explores all dimensions of bilateral relations.

'This book reflects our achievements, as well as the potential we can still realize, and we believe that it will inspire and encourage the strengthening of our future cooperation and contribute to the further deepening of the mutual friendship between Croatia and India.'

Notably, PM Modi, during his visit to Zagreb yesterday was greeted by the chanting of Sanskrit mantras by a group of Croatians, who were in Indian attire and with sandalwood tilak on their foreheads.

During PM Modi's visit to Croatia yesterday, the two leaders held talks and signed some agreements.

### **India's Covid cases** below 6k; three deaths in past 24 hrs

New Delhi: India's active Covid-19 caseload fell to 5,976 on Thursday, marking the fourth straight day of decline, down from 6,483 the previous day, according to data from the Ministry of Health and Family

In the last 24 hours, three Covid-related deaths were reported—two from Delhi and one from Kerala. All three individuals were elderly and had pre-existing chronic health conditions like kidney disease and acute rheumatoid

While the overall national trend remains encouraging, health authorities continue to monitor localised outbreaks, driven in part by emerging subvariants such as LF.7, XFG, JN.1, and the newly detected NB.1.8.1. The authorities have also advised people to adopt Covid norms like wearing masks in crowded areas and maintaining hygiene and focusing on immunity.

Ahmedabad Police Commissioner GS Malik said on Thursday that 222 people have been identified so far in the Air India 171 crash incident, and their bodies have been handed over to their respective families

Speaking to the media, Malik said that out of 222, 213 were identified based on DNA samples

"Police also do their part of the investigation, but other agencies and the experts do the technical part, like analysing the black box, and the investigation is underway... 222 people have been identified so far, 214 based on DNA samples and eight were identified without DNA and their bodies have been handed over to their families," the Ahmedabad Police Commissioner said.

Meanwhile, the mortal re-

mains of the co-pilot of the flight, Clive Kunder, were brought to his residence in Mumbai today.

Visuals from his residence showed a crowd of people gathered at his place while his family stood in front of his portrait and mourned their tragic loss. Kunder lived with his mother and father in the Goregaon (West) area.

The tragedy claimed 241 lives out of 242 onboard, including former Gujarat Chief Minister Vijay Rupani.

### Gujarat police apprehend 200 illegal Bangladeshis by Gujarat Police in the last 100 Deportation process underway

### RTI activist files complaint, blames DyCM for RCB stampede

Bengaluru: An RTI activist TJ Abraham on Thursday alleged that the June 4 stampede during celebrations linked to the Royal Challengers Bengaluru (RCB) was "orchestrated and politically motivated," resulting in the deaths of 11 people. He named Karnataka Deputy Chief Minister DK Shivakumar as the prime accused and lodged a formal complaint at Cubbon Park Police Station seeking criminal action.

This was not an accident. Eleven people were killed in a planned stampede. I have filed a complaint naming DK Shivakumar as the first accused," Abraham told media shortly after submitting the complaint to the Cubbon Park police.

Abraham alleged that Shivakumar had been in secret negotiations to acquire the RCB franchise. "He offered Rs 8,600 crore, but the deal fell through as the asking price was Rs 17,000 crore. Despite this, he contin ued to associate himself with RCB and ap pears publicly with the team's logo behind him. In what official capacity?" he asked.

## Karnataka hikes Muslim housing quota to 15 pc

Bengaluru (UNI): In a major welfare-oriented initiative, the Karnataka government on Thursday approved an increase in the housing quota for the Muslim community under various state-run schemes, raising the reservation from 10 per cent to 15 per cent.

The decision, passed in the state cabinet meeting earlier in the day, will be applicable to all housing programmes administered by the Department of Housing in both rural and urban areas. The move is aimed at ensuring broader access for Muslims to government-supported housing projects.

Deputy Chief Minister DK Shivakumar, briefing the media after the meeting, said the decision was based on the Muslim community's population ratio and the persistent underutilisation of housing schemes.

This decision has been taken keeping in mind the population ratio and the underutilisation of several housing projects. It is essential to fill these vacancies, and the Muslim' community, given its population share, deserves increased representation in welfare housing," Shivakumar

### Death toll in Mumbra train accident rises to 5, one victim critical

Mumbai: The death toll from the June 9 suburban train accident near Mumbra station has risen to five, with 51-yearold Anil More succumbing to his injuries at a private hospital on Thursday morning.

More passed away at around 11 am, confirmed Thane Tehsildar Umesh Patil.

The incident had claimed four lives on the day of the tragedy, when overcrowding led to passengers falling from a moving local train during morning peak hours between Diva and Mumbra stations.

Another injured commuter, 40-year-old Shiva Gavli, remains in critical condition and is on ventilator support at the hospital. The remaining injured individuals have reportedly been

treated and discharged.

Authorities are investigating the circumstances sur-rounding the incident, which involved a severely overcrowded train.
