

MP native Manisha safely returns from Qatar

Bhopal: In a significant relief for her family and the state, Manisha Bhatnagar, a resident of Ujjain, Madhya Pradesh, who was stranded in Doha, Qatar, amidst the escalating Iran-Israel conflict, has successfully returned home. Chief Minister Dr. Mohan Yadav personally connected with Manisha via phone to inquire about her well-being, expressing immense gratitude to the Government of India for their pivotal role in her safe repatriation, likely under “Operation Sindhu.”

Manisha Bhatnagar, a Senior Cabin Crew member with Qatar Airways, found herself caught in the geopolitical crossfire. Upon learning of her plight, Chief Min-



ister Dr. Mohan Yadav swiftly intervened, urging Union Home Minister Amit Shah for assistance. He also directed state officials to maintain close coordination with the central government to ensure her safe return.

Following her arrival back in India, Dr. Yadav engaged in a video call with Manisha, personally checking on her condition. A relieved Manisha extended her heartfelt thanks to the Chief Minister for his crucial intervention and support during a period of intense uncertainty.

This successful repatriation highlights the collaborative efforts between state and central governments in safeguarding Indian citizens abroad during crises.

Digvijaya Singh noticed in defamation case by MP-MLA Court

Jabalpur: The MP-MLA Court has issued a notice to former Chief Minister and current Rajya Sabha MP, Digvijaya Singh, in a defamation case filed by a BJP MLA. Special Judge D.P. Sutrakar, after hearing the complaint, has directed Singh to present his side. The next hearing for the case is scheduled for July 21, 2025.

The defamation suit was filed by Sushil Tiwari, a BJP MLA from Jabalpur's Panagar constituency. Tiwari alleges that on May 15, 2023, Digvijaya Singh held a press conference in Jabalpur, publicly accusing him of black-marketing 50 to 60 percent of grains from the Public Distribution System (PDS). The complaint states that Singh's remarks, also shared on social media, damaged Tiwari's reputation among party leaders and voters, potentially impacting his electoral performance.

The Special Judge, noting the applicant's statement has been recorded, deemed it essential to hear the respondent's perspective. Consequently, the court ordered the issuance of a notice to Digvijaya Singh.

Advanced agriculture key to doubling farmer income – Agricultural Production Commissioner

Bhopal: Madhya Pradesh is ushering in a new era of agricultural transformation, focused on doubling farmer incomes through innovation, crop diversification, and allied ventures. Agricultural Production Commissioner Ashok Barnwal, outlining the state's forward-looking strategy under Chief Minister Dr. Mohan Yadav's vision, emphasized integrating modern practices with on-ground support.

At a recent review of Rabi 2024-25 and planning for Kharif 2025, Barnwal advocated a strategic shift from paddy to more lucrative and climate-resilient crops like soybean and tur (arhar). He stressed adopting bio-fortified seed varieties—such as iron-rich wheat (HI 1650 series) and high-yielding Pusa

Arhar 16—to boost both nutrition and output.

The state is ramping up irrigation modernization with subsidized pressurized pipe systems, while promoting the use of Custom Hiring Centers for advanced farm equipment. Farmers are being encouraged to switch from DAP to nutrient-balanced NPK fertilizers and to utilize soil testing for smarter input use.

In a strong environmental push, stubble burning is being discouraged in favor of happy and super seeders, preserving soil health. Successful innovators will be spotlighted as model farmers.

Digitally, MP is expanding e-mandis and promoting the 'Farm Gate App' to enable direct-from-farm

sales. In fisheries, Bhopal aims to become a model district via cage culture and biofloc systems, with credit support through 'Machhua Kisan Credit Cards'.

Dairy development is also in focus, with new milk routes, breed improvement, and nutrition plans to help add 5 million tonnes to the state's milk output—cementing MP's place as a dairy powerhouse.
