Congress stages Fast-Satyagraha in Gwalior for Ambedkar statue

- Digvijay, Jitu Patwari, Singhar and dozens of MLAs sat for 6 hours
- CM Yadav sharply criticized Congress's Satyagraha

Gwalior: In a powerful display of constitutional advocacy, prominent Congress leaders staged a sixhour 'Upwas Satyagraha' (fasting protest) in Gwalior yesterday. The demonstration, held in support of installing an Ambedkar statue on the High Court's Gwalior Bench premises, saw the participation of Predesh Congress Committee President Jitu Patwari, former Chief Minister Digvijaya Singh, Leader of Opposition Umang Sing-har, and dozens of MLAs.

Addressing the media, Digvijaya Singh challenged the opposition to the statue, stating, "The question is whether Ambedkar's statue should be installed or not. We say it should. Some Gwalior lawyers, citing a non-Constitution Assembly



member B.N. Rao, claim he wrote the Constitution, not Babasaheb. Who is B.N. Rao?" Singh warned the "double-engine government" that failure to install the statue would expose their anti-Ambedkar stance, linking it to alleged past actions of the RSS. "They burned the Constitution; today it's proven," he

Former Minister Sajjan Singh Verma condemned those "tarnishing Babasaheb's Constitution," criticizing BJP and RSS-aligned lawyers for opposing a judiciaryapproved statue. "This is BJP's true character – dark-hearted people,"

he asserted.

PCC President Jitu Patwari sharply rebuked the BJP, suggesting they should observe "Black Day" for their "sins." He highlighted Madhya Pradesh's high rates of missing Dalit women and atrocities against Dalits, alongside alleged political horse-trading by the

Modi government.

"If dissolving 12-13 govern-

ments and buying over 600 MLAs isn't a Black Day, what is?" Patwari

CM Yadav slams Congress's 'Crocodile Tears', cites past treatment

Bhopal: Chief Minister Dr. Mohan Yadav today sharply criticized the Congress party's "Satyagraha" in Gwalior concerning Dr. B.R. Ambedkar, dismissing it as "crocodile toors"

"Today, our Congress friends are shedding crocodile tears in Gwalior in the name of Dr. Ambedkar. This is the same Congress that inflicted numerous pains upon him during his lifetime," CM Yadav

He urged Congress members to abandon their fast and instead "remember the sins of their past and pray for forgiveness." The Chief Minister's comments come amidst a political stir over the proposed installation of an Ambedkar statue on the Gwalior High Court premises, an initiative that has seen the

Brothers accused of murdering elder sibling

Land dispute turns deadly



tragic fratricide on Monday night in Chorwari village, under the Singhpur police station jurisdiction. Police report that Jairam Kushwaha was allegedly beaten to death by his two younger brothers, Lalman and Mohan Kushwaha, and their respective sons, Ramsharan and Braj Kishore. The fatal assault occurred around 10 PM. According to information received Jairam and his wife were sleeping in a temporary shelter in Kherwa when the four accused forcibly dragged Jairam to their old family home. There, they allegedly attacked him with sticks. Jairam's son, Ravishankar, who was constructing a cattle shed nearby, was

to intervene. Jairam's daughter-in-law Heera Bai, and younger son, Ravikaran who rushed to his aid, were also beaten. All injured individuals were initially taken to Nagod Hospital before being transferred to Satna District Hospital Tragically, Jairam succumbed to his in juries around 8 AM on Tuesday morn ing while undergoing treatment. Fami ly members confirm the ongoing land dispute over the very plot where Ravis hankar was working. The Singhpur po lice have registered a case and initiated an investigation. After the postmortem examination of the deceased authorities are now actively searching for the absconding accused.

Double horror: Woman gang raped twice in 8 days

Police inaction questioned

Satna: In a shocking incident that has ignited outrage and raised serious questions about law and order in Maihar district, a woman was allegedly gang-raped twice within eight days in the Tala police station area. The audacity of the perpetrators was reportedly fueled by the police's initial inaction after the first assault. The horrific ordeal began on June 15th when the woman, en route to Papra temple with her cousin, was forcibly abducted by half a dozen individuals. She was then brutally gang-raped, beaten, and robbed of her jewelry and cash, with the attackers threatening her life if she

reported the crime. Despite her courage in filing a complaint, no significant ac-tion was taken by the police. This alleged negligence led to a second, equally horrific attack on June 23rd, when the same

perpetrators again assaulted her.
Only after the case gained public attention did the police announce the arrest of two suspects, Arvind Loni and Pushpendra Kushwaha, with a manhunt launched for the remaining four identified and three unidentified accused. The police have registered a case under sections related to gang rape, robbery, and assault. This disturbing sequence of events highlights serious concerns regarding women's safety and police accountability in the region.

Jabalpur man dupes victims with 'Tantric Ritual' scam

Hands out fake 'Children Bank' notes

Jabalpur:In a bizarre and brazen scam, a fraudster in Jabalpur lured people with the promise of multiplying their money sixfold through tantric rituals, only to hand over bundles of fake notes — some even labeled "Children Bank of India." The scam came to light in Gohalpur police station limits after a vigilant victim, Aniket Rai, exposed the fraud. Aniket was contacted by Vinay alias Vinnu Rahangdale, a resident of Lalbarra, Balaghat, who claimed he could use occult rituals to magically increase cash four to six times. Tempted by the offer, Aniket gave him Rs 15,000 in real



currency. Vinay performed a brief "ritual," then handed Aniket a bundle supposedly containing Rs 75,000. But when Aniket opened it,

he discovered a scam — while the top and bottom notes were genuine Rs 500 bills, the middle stack contained counterfeit "Churan" notes from a toy currency set. Quick to react, Aniket caught the conman and handed him over to the police. Officials recovered Rs 75,000 in fake notes, and Vinay was arrested. According to Station In-Charge Ritesh Pandey, Vinay had duped multiple victims with similar schemes. Police are now interextent of the racket. This case highlights how superstition and greed are being exploited in the most deceptive ways — and how awareness can stop conmen in

constable recruitment One arrested for securing job by biometric tampering

Shahdol: Police have uncovered a major fraud in the Madhya major traud in the Madhya Pradesh Police Constable Recruit-ment examination. A man named Manish Gurjar has been arrested for securing the constable job by manipulating biometric data and having someone else appear for the exam in his place.

the exam in his place.

The accused has been taken into police remand for detailed interrogation. According to police sources, the fraud came to light during document verification of selected candidate Manish Gurjar, a resident of village Cheemak in Dabra tehsil, Gwalior district. A

mismatch was found in the biometric details linked to his Aadhaar card. Upon further investigation, it was confirmed that someone else had appeared for the re-cruitment exam using forged bio-metrics, while Manish was later appointed as a constable using that false identity.

The Shahdol police conducted a detailed comparison of photographs, fingerprints, documents, and handwriting, which conclusively proved that two different individuals were involved — one who gave the exam and another who assumed the job. The person

who wrote the exam had updated the Aadhaar biometrics to match his own fingerprint, enabling him to impersonate Manish Gurjar.

Police focusing on uncovering the entire network: ASP

Additional Superintendent of Police Abhishek Diwan confirmed the arrest and stated that the poing the entire network behind the fraud. They suspect a larger con spiracy involving multiple individ uals. The investigation is ongoing and more arrests may follow as police dig deeper into the racket.

Ban on celebratory firing near **Gwalior Air Force Station**

Gwalior: District Magistrate Ruchika Chauhan has issued a strict prohibitory order banning celebratory firing across the entire revenue area of Gwalior district, including within a one-kilometer radius of the Air Force Station Maharajpura. This step has been taken under Section 163 of the Indian Civil Defense Institution Code, 2023, to ensure the safety of military and civilian aircraft, personnel, and

The decision follows a recent Air Field Management Committee meeting, where the Commanding Officer of the Air Force Station reported the discovery of fired bullets and metal fragments in the aircraft operation zone. Since the Air Force Station is situated near residential areas, such materials pose a serious threat to human life, aircraft, and military equipment.

Masked robbers attack siblings-in-law

Flee with valuables

Dabra, Gwalior: In a daring late-night robbery that punity, a woman and her brother-in-law were accosted at gunpoint by three masked assailants in Dabra, Gwalior district. The brazen thieves made off with a significant haul of gold and silver jewelry, leaving the victims shaken. The incident occurred as Sapna Baghel and her brother-in-law, Chhotu Baghel, residents of Gohinda village, were traveling by motorcycle. According to reports, three masked individuals on an Apache motorcycle ambushed them, brandishing weapons and blocking their path. The robbers then proceeded to violently assault them before stripping Sapna of her ornaments. The stolen items reportedly include a mangalsutra, a gold necklace, gold 'bijasan' (a type of ornament), an 'Om' pendant, a silver waistband ('kardhani'), earrings ('jhumki'), toe rings ('bichhiya'), and silver anklets. After the terrifying ordeal, the culprits fled the scene.



Lovekush Baghel, who filed the complaint, recounted the harrowing experience, stating that the masked men on the Apache bike not only displayed weapons but also physically assaulted them before snatching the jewelry. Police have registered a case and launched an investigation to apprehend the perpetrators. This incident highlights a worrying trend of increasing crime in the region, prompting calls for enhanced security measures.

Drunk teacher creates scene in front of students, suspended

has been suspended after allegedly arriving at a government primary school in an intoxicated state and misbehaving with the staff. The incident occurred on June 23 in Singhana village under the Manawar development block, about 50 km from the district headquarters. A video of the teacher's unruly behavior surfaced on social media, prompting swift action from the authorities

Teacher misbehaved with laborers and school staff: Assistant Commissioner of the Tribal Education Department, Narottam Varkade, confirmed the suspension and stated that a departmental inquiry is underway. He said the teacher, Kavita Koche, created a scene in front of students and misbehaved with laborers and brought disrepute to the institution but

also negatively impacted the students. This is reportedly the first such case in the district where a teacher has caused a public disturbance at school under the influence of alcohol.Officials said that there have been earlier complaints about teachers consuming alcohol, but none as severe. Following the viral video, the district administration instructed Manawa Block Resource Coordinator (BRC) Kishore Kumar to investigate the matter A joint team comprising the Block Edu cation Officer and BRC was formed Based on their findings, the teacher was suspended, and further disciplinary ac tion will be taken after the departmental inquiry concludes.
