Tree plantation drive sparks political tussle in Indore

Minister Kailash Vijayvargiya alleges lack of support

Indore: A major environmental campaign in Indore, the plantation of 5.1 million saplings has taken a political turn. During a recent public event, State Minister Kailash Vijayvargiya publicly criticized the Forest Department, alleging that it was not cooperating with the large-scale tree plantation efforts across the city. His comments, made on stage in the presence of the Chief Minister, stirred immedi-

Forest department issues clarification: In response to the minister's remarks, the Indore Forest Department issued a press release defending its role. The department stated that it is actively participating in plantation activities and is providing saplings to the public — though these are available for a fee. The statement aimed to clarify its position but instead intensified the debate.

Congress enters the fray with a sym**bolic gesture:** Sensing an opportunity,



the Congress party stepped into the issue. Vivek Khandelwal, Acting President of the Congress Seva Dal, announced that Congress workers would visit the BJP office to donate

the Forest Department is being accused of leaving.

Khandelwal remarked, "The Forest Department has already stated that saplings can be bought. Despite this, a senior BJP minister complains.

So, we will provide the saplings ourselves to support their campaign." BJP hits back, calls it a misunderstanding: The BJP responded strongly to Congress's involvement. Rajendra Rathore, MIC member and in charge of horticulture at the Indore Municipal Corporation, countered the Congress's claims, stating that the issue raised by Vijayvargiya wasn't about sapling availability - but about the quality and type of saplings provided by the Forest Department.

He added, "Congress clearly doesn't understand the issue. The Municipal Corporation already has a large supply of plants ready for the cam-

1 dead as swollen stream sweeps away tractor with 11 aboard



Sheopur: A harrowing incident unfolded in Sheopur, where a group of 11 individuals faced a terrifying ordeal as their tractor was swept away by a fiercely overflowing stream. The tragic accident claimed the life of Samandev Jatav, who was crushed by the tractor. The incident occurred in the Seshaipura police station area. A tractor, ferrying passengers to Morvan village, attempted to cross a submerged causeway inundated by heavy rains. However, the driver lost control

amidst the strong current, leading to the tractor and its attached cultivator being engulfed by the surging water While approximately three people sustained injuries, others miraculously clung to nearby trees to save them selves from the raging torrent. Villagers quickly sprang into action, extending ropes from the trees to rescue those stranded. The injured have been admitted to Karahal Hospital. Authorities have launched an investigation in

Bhind Collector accused of slapping student

Police complaint filed



Bhind: A serious allegation has emerged against Bhind District Collector Sanjeev Srivastava, accused of slapping a student. The student, Rohit Rathore, has filed a police complaint

demanding action. The incident gained traction after a video circulated widely on social media. Mehgaon Po-lice Station In-charge Mahesh Sharma confirmed receiving the complaint late last night and has sought guidance from senior officials. The alleged incident dates back to April 1, during a graduate examination inspection at Pandit Deendayal Dangroliya College in Ladampura, Mehgaon police station area. Video footage reportedly shows Collector Srivastava summoning student Rohit Rathore to the college office and slapping him after the student allegedly didn't receive his exam paper. Rohiť claims he failed that particular exam. With the video now viral, he says public sympathy and support emboldened him to pursue action against the Collector.

Controversy over Madhais Mosque escalates in Jabalpur Protests over alleged illegal construction



Jabalpur: Tensions have flared in Jabalpur's Ranjhi area over the Madhais Mosque, with Hindu organizations accusing it of being illegally built on temple land. Groups including the Vishwa Hindu Parishad (VHP) and Bajrang Dal allege that the mosque encroaches on property



Collector targeted, mock funeral held: Furious over the district administration's clean chit to the mosque committee, protesters held a demonstration near the site and symbolically staged a mock funeral procession of Collector Deepak Saxena. The protest turned tense, prompting police to deploy water cannons to

Shutdown announced for July 16: Hindu groups are now demanding the removal of the Collector, accusing him of biased action. They have declared a citywide bandh (shutdown) on July 16 as part of their continued agitation.

Dispute over land ownership: Hindu leaders claim the Waqf Board was allotted only 1,000 sq ft, while the mosque has allegedly been built on over 3,000 sq ft, including survey number 169, claimed to be temple land. They also allege the presence of an unauthorized madrasa on-site.

Mosque committee defends legality: The mosque committee asserts the land was legally purchased in 1973 and later declared Waqf property, with the mosque completed in 1985. They claim the temple trust lacks supporting

Administration promises fair probe: The dis trict administration cited discrepancies in land records as the cause of confusion. Officials confirmed that the matter is already under review in the Collector's court and assured a fair and

Woman dies in hospital, three who brought 18-year-old girl kidnapped and raped her flee after giving fake address



Gwalior: A sensational and mysterious case has emerged from Gwalior district, where a 30-year-old woman named Soni was admitted to the district hospital by three unidentified individuals who provided a

fake address of Chetakpuri. Tragically, the woman died during treatment, and the three individuals who brought her fled the scene immediately after. When the Murar police began investigating the matter, they discovered that the address provided during admission was false. Suspicion deepened, prompting the police to launch a search operation based on CCTV footage captured at the hospital. In the CCTV video, one of the men is seen carrying the unconscious woman in his arms and taking her into the hospital. The footage is now central to the investigation. The woman's body has been sent for post-mortem to determine the cause of death. Meanwhile, police are working to establish whether the woman was already unwell or if she was a victim of foul play. The trio who gave false information and then absconded are currently under suspicion, and efforts are ongoing to trace them.

Concerned, the family consulted Dr. Shailendra Rathore, who, after initial examination. advised them to seek specialized cardiac care in Indore. The family took Zeeshan to Medanta Hospital in Indore, where doctors diagnosed him with swelling in the heart veins, reduced blood flow, and a valve disorder-conditions requiring expensive surgery. Minor severely burnt by live wire amid waterlogging

Indore: A tragic accident occurred on Sunday in Banka Panchayat under the Chandannagar police station area of Indore following heavy rains and severe waterlogging. A minor suffered critical burn injuries after coming into contact with a live electric wire that had snapped and fallen onto the road.

CCTV footage of the incident has surfaced, showing the minor attempting to remove the wire. Moments later, he is seen getting electrocuted and writhing in pain on the flooded street. Locals rushed him to a nearby hospital, where he is currently undergoing treat-

ment. His condition remains critical. In the aftermath of the cused the Municipal Corporation and the Electricity Department of gross negligence. They claimed that despite the danger posed by the exposed wire after the rains, no timely action was taken to remove it, leading to the accident. The Chandannagar police have launched an investigation. Omkareshwar, Khandwa: A devastating road accident unfolded on Monday on the Narmada Bridge in Barwah, Khandwa district, Madhya Pradesh. A speeding, uncontrolled tractor-trolley collided with a motorcycle, claiming the lives of a father and his young son. In a shocking turn, the tractor also careened off the bridge after impact. The motorcycle was carrying 35year-old Mohan, his 8-year-old son Anay, his 30-year-old wife Jyoti Bai, and their 12-year-old daughter Sivanya. Both Mohan and Anay tragically died at the scene, while

Jyoti Bai and Sivanya sustained minor injuries and are currently receiving treatment at Barwah Civil Hospital. According to Police Station In-charge Balram Singh Rathore, the family was traveling from Barwah to their village, Morghadi, when the tractor, heading from Sanawad to Bar-wah, struck their bike on the Narmada Bridge. Hundreds of religious figures have gathered, expressing strong resentment over the government's move. They allege that despite their years of service in managing and cultivating thousands of acres of temple land, the administration is now planning to auction these lands, which they term as a

Encroachment on monastery properties:

The protesting priests also accused the local administration of turning a blind eye to illegal encroachments by land mafias on monastery properties. They claim that no steps are being taken to free the encroached lands, further fueling their anger. The auction notice was reportedly issued under the Devasthan Temple Management Committee Rules, 2019. Protesters have warned that if the auction is not withdrawn, the agitation will expand beyond Gwalior-Chambal and spread across the entire state of Madhya Pradesh.
