

"Madhya Pradesh: A pothole-riddled state," declares Jitu Patwari

Bhopal: A dramatic 10-foot-deep sinkhole at Bhopal's bustling Board Office Square has ignited a political firestorm, with State Congress President Jitu Patwari declaring, "Looking at the state of the roads, it feels as if only potholes have been developed in Madhya Pradesh." He branded the road collapse not just a structural failure, but a symbol of the state administration's systemic collapse in governance and accountability.

Patwari asserted that the incident, occurring at the capital's busiest intersection, points to the use of substandard materials by the Municipal Corporation and PWD, pervas-



sive corruption in ongoing construction, and a clear lack of oversight from government leadership.

Widespread decay: A "Pothole Government" across MP

This crisis extends far beyond Bhopal. Across Madhya Pradesh, roads, bridges, and lanes are riddled with dangerous potholes. From Indore's frequently repaired Super Corridor to Gwalior's rain-induced "lakes" and Jabalpur's infrastructure, the problem is rampant. Rural areas suffer from broken link roads and dubious construction under the Prime Minister Rural Road Scheme. Tribal re-

gions often lack basic paved roads, or existing ones are damaged by illegal dumping.

Damning statistics and accusations

Patwari highlighted alarming figures: over Rs 45,000 crores spent on road construction since 2018, yet RTI revelations show 80% of rural roads fail within two years. He pointed to 60% of tenders going to a single contractor group and confirmed irregularities by Lokayukta and EOW in multiple districts.

"Chief Minister Mohan Yadav and his 'Double Engine Government' must explain: if roads in the capital are in this state, what about villages and towns?" Patwari demanded, questioning if public money went to public convenience or "corrupt officials' pockets." Madhya Pradesh's roads are now a testament to government corruption, not progress. The Congress Party vows to stand with the public in this fight for accountability.

Bangladeshi national held in Tallaiya

Had been living under false identity as eunuch

Bhopal: A Bangladeshi national, identified as Abdul Kalam, has been arrested by the Tallaiya police in the Budhwara locality of Bhopal for allegedly residing in India under a false identity for several years. According to police officials, Kalam had assumed the identity of a eunuch named 'Neha' and even succeeded in acquiring official documents under the fictitious name.

Forged documents seized: Following his arrest, police recovered several forged identity documents from Kalam. Preliminary questioning revealed that he had been living in Bhopal for an extended period, raising concerns about his activities and the authenticity of his claimed identity. Officials have confirmed that the process for his deportation has already been initiated.

Investigation into criminal background underway: Kalam is currently being held at the Tallaiya police station, where investigators are interrogating him to determine the exact duration

of his stay in the city and whether he has been involved in any criminal or suspicious activities. Authorities are also checking if any police cases have been registered against him in the past.

In addition, Kalam's mobile phone data, call records, and chats are being thoroughly examined as part of a broader probe into his local and possibly cross-border activities.

Intelligence agencies join probe: Given the sensitive nature of the case, intelligence agencies have also joined the investigation to trace Abdul Kalam's local and international connections. Sources indicate that investigators are exploring whether Kalam may have links to any larger networks or organizations.

Due to the gravity of the matter, police officials have chosen to maintain strict confidentiality regarding the case. Kalam has been placed under continuous surveillance by female constables at the police station.
