

Cong stages unique protest with buffalo

Bhopal: In a striking display of dissent, Congress MLAs in the Madhya Pradesh Assembly staged a unique protest on Monday, targeting the ruling BJP government with a symbolic buffalo and a traditional Indian wind instrument, the "been." The opposition employed this unusual theatrical gesture to underscore what they described as the government's insensitivity and silence on crucial public interest issues.

Before the day's legislative session commenced, Congress MLAs, led by Leader of Opposition Umang Singhar, arrived at the Assembly premises with a buffalo. Emulating the Hindi idiom "Bhains ke aage been bajana" (playing a flute before a buffalo, implying a futile effort to reason with someone unresponsive), they sharply criticized the

government. Lawmakers were seen playing the 'been' during the demonstration. Singhar asserted that the

BJP government remains completely unresponsive to public concerns, likening their inaction to a buffalo that neither hears

nor understands. He stated the government offers no reaction to the serious questions raised by the opposition.

This evocative protest followed a similar demonstration on Sunday, where Congress MLAs used symbolic chameleons to convey their message. On Monday, Chief Minister Dr. Mohan Yadav addressed the matter in the House, remarking, "Yesterday a chameleon was brought, today a buffalo has been brought."

We are all representatives of the people. We should behave in accordance with parliamentary dignity." The Chief Minister urged the opposition to conduct their protests with decorum and respect, emphasizing that the Assembly is a platform for serious discussion, not a means for mockery.
