On the night of Thursday, she went to the house of an auto driver to pay his dues. When coming back, she tried to cross the railway track at Sitampet gate. At the same time, an express train ran over her, killing her instantaneously.

School shut after pupil sprayed with cleaner

Mumbai: Authorities have ordered the immediate closure of Howard English School in Nallasopara following disturbing allegations that a teacher sprayed cleaning solution on an eight-year-old student's private parts. The incident, alleged to have occurred on April 29, prompted the child's parents to file a formal police complaint on July 23 after the school administration failed to address their concerns. According to the complaint filed by Sonal Randive (38), her second-grade son was one of only three students present when teacher Nidah Nizauddin complained of an odour in the class-

SC suggests BJP leader withdraw defamation case against Tharoor

The Supreme Court today asked BJP leader Rajiv Babbar to consider closing the defamation case filed against Congress MP Shashi Tharoor over his 2018 remark comparing Prime Minister Narendra Modi to a "scorpion sitting on a Shivling."

A Bench comprising Justice M.M.

Sundresh and Justice N. Kotiswar Singh questioned the sensitivity surrounding such statements and observed, "Let us close all these things.

Why to get so touchy about all this? This way, administrators and judges come in the same group and have thick skin." The court was hearing Tharoor's appeal challenging a Delhi High Court order dated August 9, 2023, which had refused to quash the defamation case.

The High Court had ruled that Tharoor's statement amounted to



defamation of the Prime Minister, the Bharatiya Janata Party (BJP), and the Rashtriya Swayamsevak Sangh (RSS), calling the remark "despicable

Tharoor's counsel argued that the

at the Bangalore Literature Festival in November 2018. A trial court had earlier issued a

summons to Tharoor based on Babbar's complaint. Tharoor then approached the Supreme Couthrough Advocate Abishek Jebaraj.

In September 2024, the apex court stayed the trial court proceedings, observing that the remark was not originally Tharoor's and appeared to be metaphorical in nature. The Court remarked that it was

unclear why the statement had triggered legal action, suggesting it seemed to allude to PM Modi's political invincibility rather than being outright defamatory.

The bench today adjourned the hearing at the request of the counsel for respondents, while hinting at bringing the matter to a close.

Fadnavis slams Congress for 'Hindu terror' narrative after Malegaon blast acquittals

Nagpur: Maharashtra Chief Minister Devendra Fadnavis today strongly criticized the Congress accusing it of deliberately attempting to brand Hindus as terrorists in the aftermath of the 2008 Malegaon blast.

Speaking to media in Nagpur on the sidelines of a public event, Fad-navis alleged that the then UPA government indulged in vote-bank poli tics by coining terms such as "Hindu terror" and "saffron terrorism" dur ing a time when global terror activi ties were being carried out by Islam ic extremists. The Congress govern ment tried to portray a false narra tive to appease a particular commu nity by claiming there was Hindu ter rorism, Fadnavis said. They did this to show they were balancing the scale, even though there was no evi dence to support it. It was a conspir acy to malign the Rashtriya Swayam sevak Sangh (RSS) and Hindutva leaders, some of whom were even ar rested without any basis, he said.

Kangana Ranaut dealt blow by HC

Defamation case over farmers' protest remark to continue

Chandigarh (UNI)

Himachal Pradesh MP and actress Kangana Ranaut has faced a setback from the Punjab and Haryana High Court, which rejected her plea to dismiss a defamation case filed against her. The case stems from a controversial statement made by Ranaut during the 2021 farmers protest.

The issue relates to a tweet by Ranaut, where she allegedly referred to an 87-year-old farmer, Mahinday Yaur from P. 1 Mahinder Kaur from Bahadurgarh Jandia village in Bathinda, as a woman who participated in the protests for "100 rupees." Mahinder Kaur subsequently filed a defamation case against Kanaut in re sponse to the remark.

Ranaut claimed she had merely reposted a tweet by a lawyer. While the detailed court order is yet to be released, the case will now proceed



in the Bathinda court. Ranaut, however, retains the option to approach the Supreme Court.

During the farmers' protest, Ranaut posted a tweet suggesting that women were participating in the agitation for "100 rupees." Following Ranaut's tweet, Mahinder Kaur filed a defamation case on January 4, 2021. After nearly 13 months of hearings, the Bathinda court issued summons ordering Ranaut to appear.

Five of a family killed, minor injured in road accident in Mainpuri

Mainpuri: Five members of a family died and a young girl was seriously injured in a road accident near Nagla Tál on GT Road in the Bewar police station area of UP's Mainpuri district. The accident occurred around 1:15 pm late Thursday when the family was traveling from Agra to Chhibramau in a car. The vehicle's driver reportedly lost control and it hit a road divider, overturning on to the opposite lane, where it was struck by an oncoming truck from the Nawiganj side. All six occupants of the car were severely impacted by the collision, police said, adding the deceased were identified as Deepak (36), his wife Pooja (34), their daugh-ters Aashi (9) and Arya (4), and Deepak's sister Sujata (50) Deepak's sister Sujata (50).

Monsoon fury wreaks havoc across HP: 173 dead since June 20

Shimla (UNI)

Himachal Pradesh continues to reel under the impact of relentless monsoon rains, with widespread land-slides disrupting life and infrastructure across the state.
As per the latest data, 317 roads,

360 power transformers, and 259 water supply schemes remained nonfunctional till 10:00 am Friday, severely affecting mobility and essential services in several districts.

The Mandi district, which has borne the brunt of monsoon devastation, reported 174 blocked roads. In Chamba, 142 transformers are down, while Kangra district faces a drinking water crisis with 134 schemes disrupted.

Rain-triggered landslides have crippled key routes, including the Kiratpur-Manali four-lane,



blocked near Samletu. Traffic is being rerouted via Nauni-Swarghat.

Chandigarh-Manali National Highway has also been blocked near the Pandoh Dam, prompting emergency clearance efforts under the supervision of SP Mandi Sakshi Verma.

Chamba district administration has ordered the closure of all schools and Anganwadi centres for the day, citing safety concerns following overnight downpours.

Landslides have disrupted 45 routes including the Bharmour-Pathankot highway, and the Chamba-Tisa and Nakrod-Chanju roads remain cut off. Power supply is down in Churah

due to transformer failure, and large segments of the Kathal-Bhera road in Dalhousie have been washed away, putting even the local sewerage infrastructure at risk.

Alarmingly, the road stretch near Magar drain ahead of Kainchi Mor— a spot previously devastated in 2023—has started sinking again. Locals demand a permanent geotechnical solution, rather than repeated temporary repairs.

According to the official monsoon damage report, between June 20 and July 31, state registered 173 deaths (including 78 in road accidents), 281 injured, and 36 missing and 1,766 homes and shops damaged and 1,313 cow shelters destroyed.

SP claims victory as Yogi govt retreats on school merger plan

Former national president of the Samajwadi Chhatra Sabha and Samajwadi Party (SP) leader Sunil Singh Sajan today claimed that the Yogi government had to ultimately bow down before SP chief Akhilesh Yadav

Taking to his official social media account, SP leader Sunil Singh Sajan wrote, "The world bows before those who can make it bow. Today, the Yogi government had to yield before our national president, Akhilesh Yadav

He further criticized the government's priorities, claiming that its focus was more on "madhushalas" (bars) than "pathshalas" (schools), and that these intentions had now collapsed. According to Sajan, the administration was forced to roll back its decision.



He alleged that the government was pushing children's bright futures into darkness, but under Akhilesh Yadav's leadership, Samajwadi workers had successfully opposed what he called an anti-education policy. Sajan described the development as a victory for all students striving to

build a golden future through educa-

Earlier Uttar Pradesh Basic Education Minister Sandeep Singh had clarified the government's stance on the school merger initiative. Despite this clarification, the Samajwadi Party continues to claim political credit

for the government's retreat. Singh explained that the decision to pair government and council schools—particularly those with fewer than 50 students—with nearby institutions was not new and had been under discussion for a long time. He assured that no school would be relocated more than one kilometer away and that no school

would be shut down. Addressing concerns about possible job cuts, the minister emphasized that not a single teaching post would be eliminated
