

SIR, an institutionalised vote theft, will not allow it in Bihar: Rahul

Araria (UNI)
Congress leader Rahul Gandhi today described ongoing Special Intensive Revision (SIR) of electoral rolls in Bihar as institutionalised “vote theft”, being committed by Election Commission in collusion with BJP and said it would not be allowed at any cost.

Gandhi alongwith RJD leader Tejaswini Prasad Yadav, CPI(M) leader Deepankar Bhattacharya and VIP leader Mukesh Sahni, while addressing media persons here, said that ongoing SIR in Bihar, was an institutionalised vote theft, which was being committed by Election Commission.



Both Election Commission and BJP were in collusion with each other for “votes theft”, in the name of SIR but it would not be allowed in Bihar, he added.”

“A large number of voters who are alive and have been exercising their franchise in last four to five elections, have been declared dead by Election Commission and their names were removed,” Congress leader said adding that several such voters, already declared dead by Commission, had met him during his ongoing “Voters Adhikar Yatra”.

Names of nearly one crore fake voters were added in electoral rolls during assembly elections after Lok Sabha elections in Maharashtra last year, he pointed out and added that the same kind of irregularities were also committed in Haryana and Kar-

nataka as well.

Gandhi said that he had raised the issues of irregularities committed in electoral rolls of Maharashtra, Haryana and Karnataka and also produced evidence.

“Instead of making any clarification on issues raised by him, Commission asked to file an affidavit otherwise such charges would be treated as baseless, he added.”

“Similar charges were also levelled by BJP leader Anurag Thakur but Commission did not ask him to file an affidavit,” Congress leader said adding that such behaviour proved the fact that Commission was not fair in its functioning.

Karnataka minister Priyanka Chharghe today launched a sharp attack on the Rashtriya Swayamsevak Sangh (RSS), describing it as a “toxic organisation” that poses a grave danger to India’s unity, democracy, and constitutional values.

In a strongly worded statement, he said that for building an enlightened and prosperous India, every citizen must take a pledge that “not even the shadow of RSS should touch us.”

Accusing the RSS of carrying forward the “poison” of Nazism and Manusmriti-based ideology that thrives on casteism and hatred, Congress leaders reiterated that the organisation has always been viewed

as an enemy.

“RSS is the enemy of the Constitution, the enemy of unity, the enemy of the national flag, the enemy of the national anthem, the enemy of India’s sovereignty,” the statement read.

Quoting historical warnings, Congress recalled how BR Ambedkar and Sardar Vallabhbhai Patel had cautioned the nation against the divisive agenda of the RSS.

It cited Patel’s February 4, 1944 notification banning the RSS, where the Deputy Prime Minister had said: “We must root out the forces of hatred and violence. RSS is being banned because it is working against national freedom and bringing disrepute to the country.”

EC now a threat to democracy & Voter Rights: Tejaswi

Leader of Opposition in Bihar and Rashtriya Janata Dal (RJD) leader Tejaswi Yadav today launched a sharp attack on the Election Commission, alleging that its actions have put democracy, the Constitution and the fundamental rights of voters in danger.

Speaking at a press conference in Araria, Yadav said, “The Election Commission has turned into a captive body. Its primary task now is to help the BJP in stealing votes.”

He said that the objective of the Voter Rights Yatra is to reach out to citizens at the grassroots level and make them aware of the reality.

He added that public response so far makes it clear

that people no longer have faith in the Commission.

Citing Prime Minister Narendra Modi’s recent remarks in Gaya about infiltrators, Yadav questioned the credibility of the statement, pointing out that the affidavit filed by the Election Commission in court regarding 65 lakh voters did not mention any infiltrators.

“I cannot understand who is speaking the truth and who is lying,” he remarked.

Responding to Lok Janshakti Party (Ram Vilas) leader Chirag Paswan’s jibe that he was acting as a follower of the Congress, Yadav shot back and ask him to reveal whose “Hanuman” he is?

NISHAD Party revamp organisation Son of Sanjay Nishad removed as state in-charge

NISHAD Party chief and Uttar Pradesh Fisheries minister Sanjay Nishad has taken a big action by removing his son from the post of state in-charge of UP.

The action comes after the national convention held in Delhi recently, where there were murmurings against the leadership for promoting family members in the party. Vyas Muni Nishad has been made the new state president of UP replacing Ravindra Mani Nishad.

On Saturday night, Party president Sanjay Nishad removed his son Sarwan Nishad, who is the Chauri-Chaura MLA from the post of state in-charge.

Now Baburam Nishad has been appointed as the new state in-charge in his place. With this action, the cabinet minister has launched a strong attack on his opponents.

Sanjay Nishad slammed the opposition leaders who accused him of nepotism. He said that I have relieved my own son from the post while being in power. Hardly any party would have taken such a big decision. For me, society and organization are above all, not family, he claimed.

President Sanjay Nishad said that those who accused me of nepotism, they should see that Nishad Party has taken a historic step in UP.

SP demands probe on charges made by Puja Pal against party leadership

“All these statements are beyond truth and indecent. These statements are inspired by the BJP and are part of a conspiracy against the Samajwadi Party,” UP SP

president Shyam Lal Pal said.

He further wrote that Puja Pal was made an MLA by the Samajwadi Party and when she was in trouble in her personal life, the Samajwadi Party and its national president Akhilesh Yadav stood by her and helped her in every possible way.

But suddenly, Ms Pal, who was previously completely safe in the Samajwadi Party, started worrying about her life and property after coming in contact with the BJP. Actually, as she herself has admitted in one of her statements, she has started having problems with the PDA associated with backward, Dalit and Muslim communities.

Trump effigy steals the spotlight at Nagpur’s “Marbat” festival

Thousands of devotees thronged the streets of Nagpur today to celebrate the centuries-old Marbat festival with great zeal and devotion.

This year, an effigy of former US President Donald Trump became the highlight of the celebrations, as participants symbolically protested against the US imposing 50% tariffs on Indian goods.

Placards hung on the Trump effigy carried sharp messages against tariff hikes. Some of them read: “Those who intimidate us with tariffs, India’s strength will make them weep,” “You call India a friend but secretly favour Pakistan”, and “those who block our goods

will see their business ruined.”

“Marbat” is celebrated every year in the Hindu month of Bhadrapada. The festival is famous for its grand processions, cultural vibrancy and sharp social commentary. Large effigies called “Marbat”, crafted from bamboo, paper, and cloth, are paraded through the streets to represent evil forces, societal problems or unpopular causes.

Smaller effigies known as “Badgyas” accompany the procession, symbolising demons and negative traits. The parade, marked by slogans, music and chants, concludes with the burning of these effigies, signifying the triumph of good over evil.
