


Gujarat Cabinet Overhaul Sparks Fear in Madhya Pradesh Ministry

BJP May Implement 'Gujarat Formula,' Putting Heavyweights on Notice

Bhopal: The political tremors from Gujarat, where the entire state Cabinet resigned for a fresh reconstitution, are causing significant anxiety among ministers in Madhya Pradesh. Speculation is rife that the BJP central leadership may implement this 'Gujarat Formula' in Madhya Pradesh as well.



Cabinet Reshuffle or Complete Overhaul?

Initially, political observers anticipated a minor cabinet reshuffle, expecting the removal of ministers

whose performance was deemed subpar or who were seen as obstacles to Chief Minister Dr. Mohan Yadav. This would have seen half a dozen ministers replaced. However, the precedent set by Gujarat—which is preparing for its assembly elections in two years—suggests that a complete, clean-slate reconstitution is possible.

Heavyweights and Controversial Ministers in Focus

The Madhya Pradesh cabinet includes over half a dozen powerful ministers who would be affected. This group includes both Deputy Chief Ministers, Rajendra Shukla and Jagdish Devda, along with cabinet veterans like Kailash Vijayvargiya, Prahlad Patel, Rakesh Singh, and Kunwar Vijay Shah.

Organizational Roles Await Seniors

The adoption of the Gujarat Formula could see senior ministers transitioned out of state governance and given larger national organizational roles. Speculation suggests at least two senior figures could be assigned as state-in-charges in other parts of the country.

Bhopal: A three-year-old girl, Ayesha Nirmalkar, died after slipping and falling in the bathroom at her grandparents' home in Bhopal's Kolar area. The incident occurred on Wednesday morning while she was visiting from Raipur, Chhattisgarh, where she lived with her parents.

Her father works in the private sector. Ayesha had been staying at her grandparents' residence in Abbas Nagar. After the fall, she sustained a severe head injury and was immediately rushed to the hospital, where doctors declared her dead.

The body was handed over to the family following a post-mortem on Thursday. Police have registered a case and launched an investigation. They are currently awaiting the full post-mortem report to determine further details.
