

Bhopal: A series of fatal road accidents across Madhya Pradesh this weekend has exposed alarming levels of negligence and speeding, resulting in a devastating toll on life. Incidents in Neemuch, Indore, and Guna claimed six lives, including a teacher, two students, and a 10-year-old child, leaving seven others seriously injured.

1. Drunk Police ASI kills teacher, injures three on Neemuch road

In a shocking case of official misconduct, an intoxicated Assistant Sub-Inspector (ASI) Manoj Ya-



dav of Jawad police station, Neemuch, caused a fatal accident after his speeding car collided with motorcycles. Teacher Dashrath was killed instantly, and three others were seriously injured. Eyewitnesses alleged ASI Yadav was visibly drunk, with police finding liquor in his vehicle. Neemuch SP took swift action, immediately suspending ASI Yadav following the grave incident.

2. High-speed Scorpio kills two engineering students in

Indore witnessed a tragic

loss when two second-year B. Tech students, Krishna Pal Tanwar and Ayush Rathore, both 20, died instantly after a high-speed Scorpio—estimated at 100 km/h—smashed into their bike late Friday

A third student, Shreyansh Rathore, is critical. The occupants of the Scorpio fled the scene, abandoning the vehicle.

The victims, all from Khandwa, were the sons of former councilors and farming families, shattering their dreams of becoming engineers.

#### 3. Two dead, including child, in Guna bypass head-on crash

A family pilgrimage to Ujjain ended in tragedy on the Guna Bypass when a speeding truck collided headon with a car carrying a family from Unnao, UP. The crash, suspected to be caused by the truck driver attempting a reckless overtake on a single-lane due to road patch-work, instantly killed Shivlal Shukla and his 10-year-old son, Kunj Shukla. Four other family members, including a toddler, were seriously injured and rushed to the hospital. Police have seized the truck and launched a manhunt for the absconding driver.

## Minor gang-raped by 3 in Govt School

Accused are residents of same village

Mauganj: A shameful incident has come to light from the Laur police station area of Mauganj district, Madhya Pradesh. A 14-year-old girl was gang-raped inside a gov-ernment the corrections of Eric men from the same village on Friday. After the incident, the accused fled, leaving the victim injured. They were arrested by the police on Saturday. The most shocking thing is that the girl continued to suffer from pain throughout the morning, but no health department official arrived at the scene.

#### Victim had left home to fetch water

According to reports, the incident occurred in a village in the Laur police station area. The minor girl left home to fetch water at around 6 p.m. but did not return for several hours. When her family began searching for her, they found her injured and unconscious in a paddy field. Upon regaining consciousness, she re-

lage gang-raped her one by one inside the government primary school. The accused then left her there and fled.

### Family alleges police assault

The victim's family immediately informed the police. The police registered a case and began searching for the accused. Howev er, the family alleges that the family, who went to file a report, was assaulted by the police on the way and even their mobile phones were confiscated. However, Superintendent of Police Dilip Soni has dismissed this allegation.

Even after several hours since the incident, the negligence of the administration and health department is clearly visible. The family says that the girl has been in pain since morning, but no doctor or health official has yet visited her. The girl is still frightened and unconscious at home.

## Peanut metal part had fallen in field during missile test

of a mysterious metal piece that fell two days ago in a field in Betul district, Mad-hya Pradesh, has been solved.

An investigation revealed that it was a device called a peanut metal part, used during missile or bomb testing. On Friday, a team from the Taku Proof Range and CPE Itarsi arrived at the scene and safely recovered

A loud explosion

n farmer Arjun Kajle's field on Thursday afternoon caused panic among villagers. The object was buried approximately 10 feet un-



der the soil. Police, forest department, and security agencies cordoned off the area overnight. On Friday morning, an expert team trieved it.

SDOP Mayank Ti-wari stated that the recovered piece was a "peanut metal part," the rear part of an explosive, often used during missile or bomb testing. He told vil-lagers that the situa-tion was completely under control and there was no need to panic.

Brigadier Sanjay Chikkara of CPE Itarsi said that this piece had bounced

off an iron ball during testing at the proof range and reached Kup-pa village, it was not a bomb-like object.

## National Child Health Program

Sehore: Sehore district has been declared a clubfoot-free district under the National Child Health Program. Mission Director Dr. Saloni Sidana presented a letter of appreciation to the Sehore District Health Department team for this achievement. CMHO Dr. Sudhir Deharia stated that the letter of appreciation commends the Sehore district health team for timely treatment of congenital conditions like clubfoot, conducting public awareness programs, early identification, and

continuous monitoring. He stated that this achievement is the result of the collective efforts of the district administration and health

Clubfoot is a congenital disorder in which the shape or direction of a newborn's feet is not normal. The feet appear to be bent inward, making it difficult for the child to walk. If left untreated, it can lead to lifelong disability.

Clubfoot is typically managed using the Ponseti Method, which involves casting, tenotomy (minor surgery), and bracing to gradually restore the foot to normal. In severe cases, surgery may be required. Early treatment can lead to a child's feet becoming completely normal.

# Encroachment removed from 100 hectares of forest land

Vidisha: Under the guidance of Divisional Forest Officer Hemant Yadav and in the presence of SDO, Sironj Himanshu Tyagi, a massive encroachment removal operation was carried out in compartment number P-516 of the Devpur Beat in Sironj in Vidisha district.

ensured a peaceful and success ful completion. Tree plantation and conservation work will soon begin in the encroachment-free area, to reforest the area and restore biodiversity.



## Patwari trapped by Lokayukta accepting Rs 2,000 as bribe in Sidhi

Sidhi: In a swift operation, the Lokayukta Rewa team today arrested a revenue official in Sidhi for accepting a bribe to submit a crucial official report. The accused, Patwari Shiv Pratap Singh (46) of Revenue Circle Mawai (Tehsil Churhat), was trapped while taking Rs 2,000 at his residence in Vivekananda Colony.

The bribe was allegedly demanded for preparing the Patwari report required in a stay-order case pending before the Nayab Tehsildar Court, Churhat. The complainant, Rajesh Singh, stated that Patwari Singh had originally demanded Rs 5,000, of which he had already taken Rs 3,000, and was pressuring him for the remaining Rs 2,000.

After verifying the complaint, the Lokayukta team set up the trap. They caught Shiv Pratap Singh red-handed with the bribe money in-



side his house.

Inspector Sandeep Singh Bhadoriya confirmed the action, noting the Patwari was charged under Section 7 of the Prevention of Corruption Act.

The arrest, which is the second Lokayukta action in Sidhi within a week, has caused a stir across the Revenue Department staff

# Turmeric

Mandla: Proving the adage "where there's a will, there's a way," pro-gressive farmer Dharmaraj Singh of Lawar village has successfully shifted from traditional maize cultivation to farming turmeric, becoming a shining example of self-reliance through innovation.

In 2017, Singh received 250 kg of Variately turmeric goods and only

Karnataka turmeric seeds and crucial technical training under a Horticulture Department demonstration scheme. Starting with a 1.5-acre trial, the immediate success prompted him to continue cultivating the high-value crop annually.

Singh's farm now operates as a dual-income model: he cultivates



turmeric under the shade of his mango and lemon orchards. This pairing not only aids the turmeric's growth but also pro-

vides additional income from fruit

Adopting a completely organic approach, Singh uses only cow dung manure, ensuring his produce is chemical-free. His organic turmeric is in high demand, fetching a premium price of ?90 to ?95 per kilogram in Jabalpur and surrounding markets. With an annual yield of 15 to 18 quintals from his small plot, Dharmaraj Singh has achieved genuine economic inde-

He inspires other farmers to leverage government schemes and adopt modern techniques, proving that self-sufficiency is attainable even with limited land.

## Man jailed for a year for selling poisonous liquor

#### 29 km of ghats to be built with Rs 700 crore before Simhastha

Ujjain: To facilitate the devotees attending the Simhastha to be held in Ujjain in 2028, approximately 29 km of ghats are being constructed at a

cost of over Rs 700 crore. In line with Chief Minister Dr Mohan Yadav's vision to provide devotees with convenient and clean bathing areas during Simhastha and other religious festivals, the Madhya Pradesh government has approved ghat construction projects worth Rs 778 crore.

Official information states that this project will include the construction of 29 km of ghats on both banks of the Kshipra and Kanh rivers, three vented causeways on the Kshipra River, five barrages on the Kanh River, and one on the kshipra River.
