Probe underway to trace source and possible wildlife trafficking network

Narsinghpur: Police have arrested three individuals and seized a leopard skin along with two leopard paws in a major wildlife crime case near Lokipar village. Acting on specific information, the police intercepted the accused while they were traveling on a motorcycle and recovered the illegal wildlife items from their possession.

According to police officials, the main accused has been identified as Kancheedi Lal, a resident of Barpani, who was found carrying the leopard skin and paws. He was allegedly attempting to sell the prohibited items with the help of Lakshmi Prasad Mehra and Deepak Mehra, both residents of Narsinghpur district. The trio was ap-



Accused were involved in illegal trade of wildlife body parts

A case has been registered against all three accused under relevant sections of the Wildlife Protection Act. Preliminary investigation suggests that the accused were involved in illegal trade of wildlife body parts, which is a serious and punishable offense.

Police have begun detailed interrogation to ascertain the source of the leopard skin and paws and to determine whether the accused are part of a larger wildlife trafficking racket. Further investigation is ongoing, and officials have not ruled out more arrests in the case.

Crime Branch recovers fake notes, printer and chemicals

Indore: Crime Branch has arrested another absconding accused involved in a gang dealing in counterfeit currency through social medical section 2012 dia platforms. The accused, Ankit Borasi, a resident of Banganga, was apprehended by a team led by Additional DCP Crime Branch Rajesh Dandotiya. During the operation, police recovered 45 counter-feit notes, a printer, and chemicals used for printing fake currency from his possession.

Dewas Police uncovers multi crore online gaming fraud ring

Cyber scam busted



Dewas Police have exposed and dismantled a highly organized racket that lured and swindled youths out of crores via fraudulent online gaming and betting applications. Police Superintendent Puneet Gehlod announced the signifi-

cant arrests on Tuesday, stating that the gang preyed on local youth with the promise of quick, high profits.

The 24/7 deception network: The investigation revealed

that the syndicate operated a round-the-clock betting network using illegal online websites. Victims were instructed to deposit money into various bank accounts before being issued gaming IDs and passwords. The ill-gotten gains were systematically channeled through UPI and other digital platforms by the accused, 11 of whom have been arrested from the Hatpipliya, Dhar, and Khandwa regions. Police seized recovery worth Rs 50,000 from the suspects. Ruined lives and suicide link: The financial devastation caused by this fraud network is severe, with many young victims suffering economic ruin. Authorities also disclosed a tragic case of suicide in Hatpipliya involving a young man who had incurred massive losses through the very same online gaming apps, underscoring the lethal gravity of the scam. Police are currently tracing associated bank accounts, digital transactions, and searching for other members of the ring. Police have urged the public, especially youth, to remain vigilant and report any suspicious online activity immediately.

accused in govt land scam **EOW files case**

Indore: The Economic Offences Wing (EOW) has registered a case against seven individuals, including former Panchayat officials, for allegedly conspiring to sell government land as private property in Ratlam district. The organized fraud, centered in Riyaon village, Piplda tehsil, has led to charges of corruption and

cheating. The scam involved systematically grabbing prime government land designated for village habitation. EOW investigation revealed that the 2011-12 property tax register was forged, and based on these fabricated entries, three fraudulent land ownership certificates were created and used.

Despite the land being officially recorded as government property, approximately 2,700 sq. ft. was split into three plots falsely claimed as private, and subsequently sold through eregistries between 2019 and

The probe confirmed that the former Sarpanch and Panchayat secretary misused their positions as public servants in a criminal conspiracy to tamper with and destroy official records, causing significant financial loss to the state for personal illegal gain. The EOW has registered the case for full investigation.
