Deputy CM extends New Year wishes

Bhopal: Deputy Chief Minister Rajendra Shukla extended warm New Year greetings to the citizens of Madhya Pradesh, highlighting a transformative era for the state's healthcare landscape. Infrastructure and medical education surge

Magh Mela 2026: Special Train halts announced for pilgrims at Prayagraj



Bhopal: As millions of devotees prepare for the sacred Magh Mela 2026, the Railway Administration has announced a significant boost to pilgrim travel. To ensure a seamless journey to the holy Sangam, 12 major trains operating through the Bhopal Division will now observe a

special two-minute halt at Prayagraj Rambag and Jhusi stations. Strategic halts for the holy dip: These additional stops are scheduled throughout January and February 2026, coinciding with the most auspicious bathing dates, including Paush Purnima (Jan 3) and

Mauni Amavasya (Jan 18). Key long-distance services—such as the Jayanagar-LTT Express (11062/61), which will provide 25 trips with this halt, and the Danapur-Udhna Express (20934/33)—have been included to manage the seasonal rush.

Connecting devotees across regions: The initiative caters to pilgrims arriving from diverse routes, including Pune, Ahmedabad, and Darbhanga. Trains like the Pune-Gorakhpur Express and Banaras-Udhna Express will also provide these crucial stops, making the pilgrimage to the "King of Tirthas" more accessible for those staying for the month-long Kalpvas.

Plan your spiritual journey: Rail authorities urge all travelers to verify train numbers and specific halt dates via the National Train Enquiry System (NTES) or the official railway website before departure. These measures are part of a broader effort to provide a safe and comfortable experience for the 12 crore devotees expected this year.

ASHA worker's timely action saves newborn

Bhopal: A baby girl born on December 17 in Akiya village of Bairaasi is steadily recovering after timely medical intervention ensured by an alert ASHA worker. Born with a weight of 2.5 kilograms, the infant's weight dropped alarmingly to 1.7 kilograms within ten days. Despite this, the family initially relied on traditional healing practices. Under the Home-Based Newborn Care program, village ASHA worker Suman Lowanshi regularly visited the mother and child. During her visits, she monitored the baby's weight and provided breastfeeding counseling. When she noticed continuous weight loss, she immediately informed her supervisor and persistently advised hospital treatment.

By Special Correspondent Indore: Madhya Pradesh Mahila Congress president Reena Baurasi Setia on Wednesday visited Bhagirathpura, where the supply of contaminated water has led to a major health crisis, leaving over 200 residents ill and claiming eight lives. She went door to door to meet bereaved families, expressed condolences, and interacted with the injured, describing the situation as "extremely grim".

intimidated for raising their voices. Following these accounts, Setia, along with women Congress workers, visited the councillor's residence and symbolically presented bangles in protest after being told he was unavailable.

Addressing the media, Setia accused the state government of making hollow claims about free medical treatment. "The reality is that patients are being asked to pay before receiving treatment," she said, adding that residents had shown her multiple hospital payment receipts. She also raised serious concerns over delays in post-mortems, citing a case where a victim's body was not examined even after 24 hours. Setia demanded strict action against Additional Commissioner Rohit Sisodia and Narmada Project

engineer Sanjeev Shrivastava, alleging an attempt to shield senior officials by targeting junior staff.

Record chill at 1.7°C as New Year approaches under foggy grip

Madhya Pradesh shiver

Bhopal: A brutal cold wave has tightened its grip on Madhya Pradesh, with the mercury plummeting to record lows across the state. In a bone-chilling start to the season's peak winter, Kalyanpur in Shahdol district recorded a minimum temperature of 1.7°C, the lowest in the state so far. The intense cold has disrupted daily life, leaving eastern regions particularly vulnerable as the year 2025 draws to a close. Meteorological onslaught: Jet streams and snowfall: According to the Meteorological Department, this "cold torture" is the result of a powerful combination of factors: heavy snowfall in the Himalayan states, an active

Western Disturbance, and a high-speed Subtropical Western Jet Stream blowing at approximately 278 km/h. These icy winds from the north have caused temperatures to crash below 10°C in over 30 cities, with Jabalpur, Rewa, and Sagar divisions bearing the brunt of the chill. New Year under a "Blanket of Fog": Revelers planning New Year celebrations face a dual challenge of biting cold and visibility-crippling fog. The IMD has issued an Orange Alert for dense fog in districts including Gwalior, Rewa, Satna, and Chhatarpur. While some divisions saw a slight marginal rise in daytime temperatures due to dry weather, the nights remain treacherous, with frost reported along the banks of the Narmada.
