

Patwari questions 'farmer welfare' claim in MP Budget

By Special Correspondent Bhopal: Madhya Pradesh Congress Committee president Jeetu Patwari has questioned over the State Budget 2026-27, dismissing its projection as a "farmer welfare" document. He said mere claims of dedication to the farming community could not conceal the distress prevailing in the fields.



Patwari. Delays in payment, lack of storage and inadequate market returns, he said, are pushing cultivators towards moneylenders

and bank loans. Citing data from the National Crime Records Bureau, he sought transparency on reported suicides of farmers and agricultural labourers between December 2023 and January 2026, and demanded details of rehabilitation, debt relief and mental health support measures. He also referred to protests in the Ujjain and Indore regions over land acquisition for infrastructure projects, alleging inadequate compensation and rehabilitation. Patwari called for a legal guarantee of MSP, expansion of irrigation, zero-interest farm loans and effective disaster relief, asserting that farmers are the backbone of the State's economy, not merely a vote bank.

Demolition drive reclaims Kaliyasot catchment

9 illegal dairies razed

Bhopal: Acting on a high-stakes mandate from the National Green Tribunal (NGT), the TT Nagar administration launched a massive anti-encroachment drive on Saturday to safeguard the Kaliyasot Dam's fragile catchment area. Led by Tahsildar Kunal Raut, a joint task force of revenue officials, municipal staff, and police deployed heavy machinery to demolish nine illegal dairy sheds that had been operating as buffalo pens in the protected zone. While the operation initially faced resistance from dairy owners—who questioned the selective order of demolition—the tension subsided once authorities issued a final ultimatum to the remaining ten structures. These operators have been granted a grace period until Holi to voluntarily vacate, failing which a total clearance will be executed. The displaced owners, residents of nearby Chhavni village, expressed their plight, claiming they had been previously relocated from Nathu Barkheda and had nowhere else to



sustain their livestock. Despite their pleas for permanent rehabilitation, the administration remained firm, citing the environmental necessity of the NGT's order initiated by activist Subhash Pandey's petition. This crackdown underscores a renewed judicial and administrative commitment to purging critical water bodies of illegal settlements. By dismantling these unauthorized commercial hubs, the district authorities aim to restore the ecological balance of one of Bhopal's vital water resources, signaling a zero-tolerance policy toward catchment encroachment. "We are strictly adhering to the orders of the NGT. This mandate was issued a significant time ago, specifically directing the removal of all encroachments within the catchment area." Food Department seizes 27 quintals of adulterated Mawa

Bhopal: With the festive season approaching, the Food Safety Department has launched a high-decibel offensive against the "adulteration mafia" across Madhya Pradesh. In a major breakthrough, authorities intercepted a massive consignment of 27 quintals of suspected synthetic mawa on the outskirts of Bhopal. Preliminary investigations suggest the stock was laced with cheap vegetable oil to mimic authentic milk solids. Simultaneous raids in Indore, Gwalior, and Jabalpur have sent shockwaves through unscrupulous traders, as the state adopts an "alert mode" to ensure Holi celebrations remain untainted by hazardous food. In the capital, three dedicated task forces are conducting daily inspections across 50 outlets, including a high-profile raid at Kabul Mishtan Bhandar in Kolar, where multiple samples of sweets and dairy products were seized for forensic analysis. To choke the supply of counterfeit goods, officials have activated a clandestine intelligence network and established rigorous border checkpoints. Hundreds of samples are being dispatched daily to state laboratories to preempt the sale of toxic paneer and standard sweets. By leveraging a combination of sudden field raids and a robust informant system, the department is determined to purge the market of adulterated ingredients, prioritizing public health over illicit profit margins this festive season.

NGT cracks down on toxic water supply

Bhopal: In a stinging rebuke over the city's deteriorating water quality, the Pollution Control Board has issued a high-priority notice to the Bhopal Municipal Corporation (BMC), demanding a comprehensive response within five days. The action follows an intervention by the National Green Tribunal (NGT), which took suo motu cognizance of reports revealing that damaged sewage lines were contaminating drinking water pipes. Investigations have unmasked a public health crisis, confirming the presence of hazardous Coliform bacteria in the city's primary water supply—a direct result of administrative negligence in maintaining overlapping utility networks. The notice, served to City Engineer Udit Garg, compels the BMC to detail its

corrective measures before the critical NGT hearing scheduled for March 9, 2026. This legal escalation traces back to January, when repeated complaints of foul, contaminated water were ignored despite evidence of structural breaches in the transit infrastructure.

Waqf land is for charity, not government control

MLA Arif Masood fires back

Bhopal: The release of the latest CAG report has ignited a fierce political firestorm in Madhya Pradesh over the ownership and management of Waqf properties. Senior Congress MLA Arif Masood has launched a scathing attack on the state government, alleging that vast tracts of land currently classified as "government property" are actually donated Waqf assets illegally occupied by the Revenue Department. Donations vs. state ownership: Masood argued that Waqf land is never "state-owned" but is private property donated specifically for social service and aiding the needy. He pointed to massive discrepancies in management records, demanding the government clarify the legal basis on which these religious endowments were registered as revenue land. "The government must come clean on the status of these properties instead of usurping assets meant for

the community," Masood stated, calling for a transparent audit of all such holdings. BJP hits back amid Assembly deadlock: Cabinet Minister Vishwas Sarang dismissed the allegations, labeling them a diversionary tactic to mask internal friction within the Congress. Sarang asserted that the opposition was given ample time for discussion in the Assembly and that the session followed all parliamentary norms. Meanwhile, Deputy Leader of Opposition Hemant Katara countered that the sudden adjournment of the House was a strategic move by the BJP to evade accountability on sensitive issues like the CAG findings and cattle welfare. As both sides dig in, the dispute over Waqf records is rapidly evolving into a major legal and communal flashpoint.
